I am directed to convey the sanction of the President for release of Grants-in-aid amounting to Rs.88302500/- (Rs.Eight Crores Eighty Three Lakhs Two Thousand Five Hundred Only) as Third Installment (25% of Central Share) to Government of Andhra Pradesh-Animal Husbandry Department towards Assistance for Quality Fodder Seeds Production under National Livestock Mission during the F.Y 2022-23.

- 2. The programme is to be implemented on the following terms and conditions.
- (a) Central Grant is sanctioned on the condition that this will be utilized for specific purpose and places / projects as per the proposal submitted by the Director Animal Husbandry department, Government of Andhra Pradesh vide AHF02-55021/71/2021-V-NLM -DAH dt 29.11.2021 & dt 22.12.2021
- (b) The estimated expenditure is to be treated as maximum and all efforts will be made to effect as much economy as possible without deterioration of the scheme and also that the expenditure incurred within the ceiling approved by the Government of India.
- (c) The **implementing agency** will maintain proper account of expenditure incurred and submit the statement of the audited accounts to the Government of India in due course.
- (d) The account of grant shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC), 1971 and internal audit by the Principal Accounts Office of the Department, whenever the Institution/Organization is called upon to do so.
- (e) The organization shall submit an audited certificate of actually utilized grants in-aid sanctioned in prescribed Performa as per GFR, 2017 specifying report on targets and achievements cum performance report to the sanctioning Authority.
- (f) The proposal will be implemented by the Implementing agency strictly as per the guidelines contained in the Scheme; conditions laid down in administrative approval issued by this
