Subject: Revalidation sanction of Rs 3.62 lakh only for the unspent amount of the release during 2019-20 under NLM Scheme to the UT of A & N Administration for utilization and settling the actual committed liability during 2021-22.

Sir,

I am directed to refer to the A & N Administration letter No. 12-2/STAT/NLM-FUND & Project- 2020-21/1430 Dated: 08.11.2021 and to say that the Department vide letter No. 99-8/2018/NLM- A& N Dated: 14.06.2019 had released Rs 22.45 lakh under NLM during 2019-20. The A & N Administration has reported that they have unspent balance of Rs 13.07 lakh and requested for revalidation of the same for utilization of the unspent amount during 2021-22. The A & N has also informed that they have committed liabilities of Rs 3.62 lakh which are to be met out of the unspent amount.

2. The matter has been examined in consultation with IFD and with the concurrence of IFD it is to convey that Rs 3.62 lakh is revalidated out of the unspent amount of Rs 13.07 lakh to be utilized during 2021-22 by 31st March 2022 to meet the committed expenditure. The expenditure of revalidated amount to be incurred by 31st March 2022 and the remaining amount to be deposited to the Department.

3. The UT of A & N Administration is requested to utilise the funds revalidated now under the NLM scheme during current financial year 2021-22 and physical and financial progress of the project may be intimated to this Department at the earliest. In case the funds are not utilized during current financial year, the same must be refunded to this Department. Further, release of funds under NLM scheme will be considered only on receipt of utilisation certificate for the above revalidated amount.

4. The UT of A & N Administration is also instructed to remit balance central fund of Rs 9.45 lakh and interest accrued up to the date of remit of central funds to Gol Account.

5. This issues with the concurrence of Integrated Finance Division vide FTS No. 18766/AS & FA dated: 14.01.2022.
