## 2. Term of reference of the CMU will be as under:

- a) To review and revise minimum standards from time to time after consultations with experts for production of quality frozen semen straws as per the OIE guidelines. Other international standard prescribed by international organizations etc.
- b) Evaluation of semen stations all over the country and categorize them either as fit for semen production or unfit for semen production. Detailed reports will be submitted to the Department soon after completion of each inspection.
- c) The CMU shall complete evaluation of all semen stations and submit the reports to this Department from time to time.

3. TA/DA of members of the CMU will be met by respective organizations. Members should be allowed to travel by air as each team has to cover good number of semen stations for evaluation in limited time. In case of emergency or exigencies TA/DA of non-official members or this organization having difficulty in meeting the expenses will be met by Department of Animal Husbandry and Dairying through CFS&PTI, Hessarghatta.
