**E-Tender Notice**

**Subject:- Awarding of Comprehensive Annual Maintenance Contract (CAMC) for 81 Air Conditioners (54 Window Type and 27 Split Type) installed in the Department of Animal Husbandry & Dairying as well as in the Office of Hon'ble Minister (FAH&D ).**

Sir,

The e-tenders are invited under **Single Bid System (Annexure)** from the reputed firm having adequate experience in the maintenance of Air Conditioners in Government Ministries/Departments/Organizations and having qualified AC mechanics/ technicians on its roll. The number(s) indicated are tentative and there could be variation of 20% on either side (increase/decrease).

2. The interested firms are advised to submit their bids "**on-line**" by visiting the Govt. of India, Central Public e-Procurement (CPP) Portal i.e. <http://eprocure.gov.in>. The bids will be accepted as e-tender only i.e. the tenderers will submit their bids on the e-Procurement Portal (module of NIC), in an encrypted format. Possession of valid Digital Signature Certificate (DSC), valid e-mail address and registration of the firm on the Government of India, Central Public e-Procurement (CPP) Portal i.e. <http://eprocure.gov.in> are pre-requisite for e-tendering.

4. The interested firms are required to deposit **Demand Draft/Pay Order** of **Rs.15,000/- (Rupees Fifteen Thousand Only)** as **Earnest Money Deposit (EMD)** in favour of **'P&AO(Sectt.I), D/o AH&D, New Delhi'**, valid for a period of 90 days, super-scribing the envelop **"CAMC of ACs of DAHD"**. Offer not accompanied by EMD of the requisite amount or without proper validity will summarily be rejected.

5. The scanned copy of the **demand draft/pay order of Rs.15,000/- (Rupees Fifteen Thousand Only)** as **Earnest Money Deposit (EMD)** must be uploaded with the Bid and original of the same has to be dropped in the Tender Box placed in **Room No. 531, 5<sup>th</sup> Floor, Krishi Bhawan, New Delhi** latest by the last date of bid submission super-scribing the envelop **"CAMC of ACs of DAHD"** i.e. by 1700 hrs. on 3<sup>rd</sup> August, 2019. The tenders received without the prescribed EMD will not be entertained and summarily rejected. The EMD of unsuccessful tenderers shall be returned after finalization of the contract.

6. The firms who are exempted from submission of EMD shall be dealt as per General Financial Rules, 2017 subject to submission of an undertaking from the firm seeking such exemption. Copies of relevant orders/documents regarding such exemption should be submitted along with the bid.

7. The firms are required to upload copies of the following documents along with their Bids, failing which their Bids shall be summarily/out-rightly rejected and will not be further considered:

- a. Scanned copy of Earnest Money Deposit (EMD)
- b. Scanned copy of Registration of the firm
- c. Scanned copy of PAN Card, GST Registration Certificate
- d. Scanned copy of experience documents of similar contracts in Central Govt. Ministries/Department/Organizations
- e. Scanned copy of certificates of qualified mechanics/technicians

8. The bidder shall quote their bids only as per the format enclosed at **Annexure**.

9. **The terms and conditions of the tender & resultant contract shall be as under:-**

(a) Tenders from only those firms will be entertained which are registered for the services desired in the tender and have GST Registration Certificate, PAN No., (Before awarding the CAMC the firms will have to show their original documents to the members of the Tender Evaluation Committee) and supporting documents to establish that the firm have adequate experience in maintenance of air conditioners.

(b) The tenders should be accompanied with the Earnest Money Deposit of **Rs. 15,000/- (Rupees Fifteen Thousand Only)** in the form of Demand Draft/Pay Order from any of the Nationalized Bank in favour of **'Pay & Accounts Officer(Sectt -I), Department of Animal Husbandry & Dairying, New Delhi'**.

(c) The Air conditioners are to be taken over for Comprehensive Maintenance on **"as is where is basis"** and could be inspected by the prospective bidders on any working day between 02.00 p.m. to 05.00 p.m. upto 3<sup>rd</sup> of August, 2019. The inspection shall be arranged through the Section Officer (Admn.II) of the Department.

**(d) The term "Comprehensive Maintenance" shall include servicing, oiling, chemical washing, gas filling, replacement of compressor, filter, thermostat, all kinds of motors, capacitors, wiring, all kinds of plugs, pads and replacement/repair of all other parts which are required to make the machines in working condition during the currency of the contract at the exclusive risk, responsibility and cost of the contractor.**

It shall be ensured that genuine certified parts only are provided and this shall be after proper inspection of old parts and new parts by a representative of the Department and under overall supervision of Section Officer (Admn.II), DAHD.

(e) It shall be obligatory on the part of the contractor to carry out repair/ maintenance of machines under his direct supervision during the period of currency and in no case this shall be sub-contracted.

(f) For regular and proper maintenance of the machines, the contractor will depute at least two qualified mechanics/technicians to this Department on all working days throughout the period of contract from 9.00 AM to 6.00 PM. If required, the services of technicians shall also be made available on Saturday/Sunday/Holidays without any extra payment.

(g) Contractor shall obtain user's certificates every month regarding satisfactory working of machines during the previous month. Deductions equivalent to twice the charges of maintenance contract separately for each default shall be made from the bill in case of any equipment remaining out of order for more than 24 hours.

(h) If in any case, the firm is not able to do the work, the same shall be got done from some other firm or from the open market at the cost of the contractor and the extra expenditure incurred thereon shall be recovered from him. This shall entail the termination of the contract; forfeiture of the performance security and debar for any future contracts from the Govt. Departments for at least five years.

(i) The contractor shall be responsible for payment of wages/settlement of dues with workers engaged by the firm as per prevailing labour/wage laws in force in NCT of Delhi. All matters/disputes pertaining to the tender and the rest of the contract shall be settled by the Head of the Department or officer nominated by him for the purpose. The contract terms are interpretable under applicable Indian Laws.

(j) The contractor shall arrange to get the character and antecedents of workers verified before deployment and their full particulars shall be furnished to this Department.

(k) The contractor shall be responsible for handing over all the Air conditioners in working condition along with all the accessories to the Department and the cost of shortcomings, if any, shall be borne by the outgoing contractor.

(l) The damage caused, if any, either to machines or to any other property of the Government through negligence or otherwise, shall be at the risk, cost and responsibility of the contractor.

(m) No extra payment/compensation whatsoever, on account of natural calamity/accident or otherwise, will be made to the firm by the Department except the rates permitted under this contract.

(n) No advance payment will be made. The payment shall be made quarterly basis in respect of the actual number of the machines repaired/maintained by the firm, on submission of bills.

(o) The contract shall normally be awarded to the lowest (for majority of the items in case of multiple item tender) evaluated bidder whose bid has been found to be responsive and who is eligible and qualified to perform the contract satisfactorily as per the terms and conditions incorporated in the tender letter. The Department reserves the option to select more than one firm for award of contract for different machines to ensure uninterrupted servicing/repairing during the currency of the contract.

(p) The Department reserves the right to reject or to accept any quotation, whole or in part, without assigning any reason thereof. **However, the bidders would have the right to question the bidding conditions, bidding process and/or rejection of its bid.**

(q) The Department also reserves the right to renew the contract for such period (s) as it may deem necessary taking into account, of course, the satisfactory services rendered by the contractor during the currency of this contract.

(r) **No conditional bids will be accepted** and such bids are liable to be summarily rejected by the competent authority at its discretion. If any of the bidders have objection with




regard to the terms and conditions of the tender, the same may be pointed out within 05 days of the issue of tender document. The quoted rates shall be kept open for acceptance by the Department within 45 days of the tender opening.

(s) The Department reserves the right to terminate the CAMC at any time during the contract period if the services of the contractor are not found satisfactory. In all matters of dispute relating to the proposed CAMC, the decision of the Head of the Department shall be final and binding on the contractor.

(t) The tenderer whose quotation is finally accepted, shall have to furnish performance security of a sum of **Rs.20,000/- (Rupees Twenty Thousand Only)** in favour of **'Pay & Accounts Officer(Sectt.I), Department of Animal Husbandry & Dairying, New Delhi'** by means of Fixed Deposit Receipt/Bank Guarantee from any of the Nationalized Banks. The Department reserves the right to forfeit the Performance Security in the event of the firm violating any of the terms and conditions of the contract and not providing satisfactory service. The Performance Security shall remain valid for a period of 60 days beyond the date of completion of all contractual obligations of the firm.

(u) The prospective bidders are free to seek any clarification from the Section Officer (Admn.II), Room No. 531, Krishi Bhawan, New Delhi-110001 (☎ # 23385116) with prior appointment on any working day before tender opening.
