Reference is invited to RfP dated 28.02.2022 on the subject mentioned above. In this connection following minor corrections are being made to the clauses of RfP as mentioned below:

Based on the quarterly plan, the samples should be collected by PLA from the manufacturer's facility (based on the written communication from manufacturer) within 7 days from the date of communication received from the manufacturer. The sample must be delivered to the designated lab (as per the directions of ICAR) within 2 days of the collection of samples. Any delay in this timeline, which is beyond the control of PLA and duly informed to DAHD with due approval, may lead to monetary consequences on the service charge of PLA, solely on the discretion of DAHD. Based on the quarterly plan, the samples should be collected by PLA from the manufacturer's facility (based on the written communication from manufacturer) within 7 days from the date of communication received from the manufacturer.
