Dist/18-19/24 dated 19.05.2021 received from Director, Animal Husbandry, Jaipur, Rajasthan on subject cited above and to convey the sanction of the President of India for the payment of Grants-in-Aid amounting to Rs.18,52,53,000/- (Rupees Eighteen Crore Fifty Two Lakh Fifty Three Thousand Only) to the State of Rajasthan under "ESVHD" a component of 'Livestock Health and Disease Control' ESVHD of Central assistance with the condition that 40% matching share will be provided by the State Government for renovation & strengthening of 6 District level Veterinary Polyclinics, 75 First Grade Veterinary Hospital, 105 Veterinary Hospital and 178 Veterinary Sub-centre / Dispensary in Rajasthan under ESVHD for the year 2021-22.

- 2. The Grants-in-Aid Rs.18,52,53,000/- (Rupees Eighteen Crore Fifty Two Lakh Fifty Three Thousand Only) have been released in accordance with the approved pattern of financial assistance under the Scheme. The release to the Rajasthan State Government is subject to the condition that the next release will be considered only after obtaining the information relating to fund-utilization and submission of Utilization Certificate by the Rajasthan State Government.

- 5. The Grant-in-Aid is sanctioned on the conditions that this will be utilized for the Scheme as specified in *para* 1 above and the estimate of the expenditure is treated as maximum and every effort is made to effect such economy as possible and also that expenditure is incurred in accordance with the ceiling approved by the Govt. of India under different Heads.

- 6. This Sanction is issued in exercise of delegated powers and with the concurrence of Finance Division of Ministry of Agriculture, Department of Animal Husbandry, Dairying & Fisheries vide their **Diary No. 18292/AS&FA dated 03.07.2021**.
- 7. It is certified that the expenditure of Rs.18,52,53,000/- (Rupees Eighteen Crore Fifty Two Lakh Fifty Three Thousand Only) have been duly noted in the Register of Grants at Serial No.1 on Page No. 270
- 8. The further use of Grants in Aid being released by this sanction order is to be done through Expenditure, Advance and Transfer (EAT) module of Public Financial Management System (PFMS). The Utilization Certificate not supported by the EAT module data is likely to be rejected and expenditure is not to be treated as regular. The State/Agency would be forced to refund the amount received as the expenditure not appearing in EAT module date is not to be taken as expenditure incurred in accordance with the terms and conditions of this sanction order.
- 9. The State Govt. is also requested to ensure registration of all the implementing agencies till last levels and use of Expenditure, Advance and Transfer (EAT) Module of Public Financial Management System (PFMS) for flow of funds so that effective monitoring of funds utilization can be done as per Rule 232 (v) of GFR, 2017.
