- 2. The programme is to be implemented on the following terms and conditions.
- (a) Central Grant is sanctioned on the condition that this will be utilized for specific purpose and places/projects as per the proposal submitted by Director KVSSL vide letter no.KVSSL/2022-23/GGN/08 dt 20.4.2022. and N.KVSSL/2022-23/GGN/109 dt 15.9.22.The detail fodder seed production programme/activities for Kharif & Rabi 2022 has already communicated.
- (b) The estimated expenditure is to be treated as maximum and all efforts will be made to effect as much economy as possible without deterioration of the scheme and also that the expenditure incurred within the ceiling approved by the Government of India.

- (e) The organization shall submit an audited certificate of actually utilized grants in-aid sanctioned in prescribed Performa as per GFR, 2017 specifying report on targets and achievements cum performance report to the sanctioning Authority.
