- 7. It is certified that the expenditure of Rs. 5,60,00,000/- (Rupees Five crore Sixty Lakh only) has been duly noted in the Expenditure control register at Serial No. 1-3 on Page No. 77 as stipulated in GFR rule 212(4)(b).
- 8. No funds were released before in the previous year; hence, no Utilization Certification is pending with the above-mentioned States as due for rendition under the Rules under the Scheme.

The State Governments is also requested to ensure registration of all the implementing agencies till last levels and use of Expenditure, Advance and Transfer (EAT) module of Public Financial management System (PFMS) for flow of funds so that effective monitoring of funds utilization can be done as per Rule 232 (v) of GFR 2017.
