

RESERVATION RELATED MATTERS - reg.

1. Parliamentary Committee on SC/STs and OBCs
(Action : All Divisions except Admin-IV)

The data pertaining to SC/ST and OBCs relating to Parliamentary Committees should be provided to Admin-I Section latest by **15.02.2019**. The said data is urgently required for onward submission of consolidated information to DoPT.

2. Online collection of data on representation of SC/ST/OBC/PWDs as on 01.01.2019
(Action : All Divisions except Admin-V)

The data pertaining to Representation of SC/ST/OBC and PWDs as on 01.01.2019 should be provided to Admin-I Section latest by **08.03.2019** for uploading consolidated data of this Department on "rrcps.nic.in" website on time.

3. Reservation for Economically Weaker Sections (EWSs)
(Action : All Divisions)

Recent instructions of DoPT in respect of Reservation for Economically Weaker Sections (EWSs) was discussed in the meeting. Joint Secretary (Admin) stressed for appropriate action for the recast of the reservation rosters/registers. It was desired that a fortnightly report commencing from 15.02.2019 may also be provided to Admin-I Section. During the course of meeting, Joint Secretary (Admin) asked the latest provision of preparation of reservation roster for each representative of Administrative Units of DAH&D and D/o Fisheries.
