Important policy decisions taken and major achievements during the month of December, 2021.

1. Cattle & Dairy Development:

- i. Secretary, AHD chaired the 2nd Project Sanctioning Committee Meeting (PSC) under restructured/realigned "National Programme for Dairy Development" scheme (Component A) on 21.12.2021 in which one project each in Karnataka and Gujarat were approved at a total cost of Rs.6692.00 lakh (Central Share Rs.4015.00 lakh) for installation of 3128 automatic milk collection units and 500 electronic milk adulteration testing machines at village level milk collection centers.
- ii. Additional Secretary (CDD) reviewed the progress of ongoing Nationwide AHDF KCC Campaign with Animal Husbandry Departments of States on 09.12.2021.
- iii. Secretary, AHD along with Additional Secretary (CDD) attended CoS meeting held on 16.12.2021 in order to review of implementation of Kisan Credit Card (KCC) scheme for animal husbandry farmers.
- iv. Secretary, AHD chaired a Central Project Steering Committee (CPSC) meeting of Dairy Processing and Infrastructure Development Fund (DIDF) scheme on 02.12.2021 wherein the following decisions were taken:
 - a) Besides receiving fund from NABARD, the National Dairy development Board (NDDB) is also allowed for direct funding to the end borrowers (end implementing agencies) under the scheme from their own resources and also to receive interest subvention @2.5% directly from D/o Animal Husbandry & Dairying.
 - b) The proposals for direct lending of fund by NCDC and scheduled banks under DIDF will be moved through EFC/CCEA route for approval.
- v. Secretary, AHD took a milk situation review meeting on 17.12.2021 and noted that the State Milk Federations were in comfortable position with stocks of SMP and Butter at present. It was decided to form a Working group comprising APEDA, NDDB and other Stakeholders from dairy sectors under the

Chairmanship of AS (CDD) for preparing a road map and strategies for export increase of dairy products.

2. Livestock Health:

- i. On confirmation of re-incidence of Lumpy Skin Disease (LSD) in Gujarat, the State was advised to take immediate bio-security and bio-safety measures including ring vaccination to control and contain the disease in a definite timeline.
- ii. On confirmation of incidence of Glanders in the States of Uttar Pradesh, Department communicated to the State to adopt zoo sanitary measures, monitor/restrict the equine movements to and from the infected area to prevent further spread of the disease.
- iii. The Department nominated Officers for the 9th Asia-Pacific Workshop on Multi-Sectoral Collaboration at the Animal-Human-Ecosystems Interface held from 13-14 December 2021.
- iv. The Department nominated Officers for Regional Tripartite Webinar on Neglected Parasitic Zoonoses organized by OIE for "Prevention and Control of Neglected Parasitic Zoonoses (NPZ) in the Asia Pacific Region" to promote One Health.
- v. The Department completed and communicated to FAO, the survey under TCPe COVID-19 project on "Strengthening Regional Capacities to Address COVID-19 Impacts on the Animal Health Sector in East and Southeast Asia".
- vi. Department constituted the subcommittee to develop the guidelines for clinical trial/field trial for veterinary drugs and vaccines.
- vii. Department supported the Proposal for the designation of NITTE University as "FAO Reference Centre for Antimicrobial Resistance(AMR) and Aquaculture biosecurity" with the advise to develop an effective linkage with INFAAR so that there is coordination in strategic implementation, generating data and communicating unified information to international community.
- viii. Department provided inputs for India's upcoming G20 Troika membership and G20 Presidency which include food safety and security, zoonoses, one health Initiative including AMR.
- ix. Department provided the inputs for inclusion in the Protocol of the 13th Session of India Uzbekistan Inter-Governmental Commission (IGC) which include export of Indian poultry and poultry products from Disease-free, high-health poultry

compartments, training and exposure of experts in the field of veterinary control and animal identification.

- x. So far cumulative 16.91 crore animals have been vaccinated against FMD as per information received from States and 21.93 crore animals have been ear-tagged in the country. The next round of vaccination against FMD has commenced and so far 4.46 crore animals have been vaccinated. The vaccination against Brucella has also been commenced and so far 27.15 lakh animals have been vaccinated.
- xi. During the month of December 2021, around 0.39 crore animals were ear-tagged, around 1.37 crore animals vaccinated against FMD and 1.91 lakh animals vaccinated against Brucellosis.

3. National Livestock Mission (NLM):

- i. Secretary, AHD chaired the second meeting of Empowered Committee under National Livestock Mission held on 24.12.21 for consideration of research proposals through virtual mode.
- ii. A review meeting was held on 28.12.2021 with States to review the status of creation of SNA, SNA mapping with the PFMS and unspent amount under National Livestock Mission under the chairmanship of Mission Director-NLM through virtual mode.

4. Credit, Extension and Publicity:

- i. Hon'ble Prime Minister launched Dairy Mark, the Logo of Conformity Assessment Scheme in a programme held in Varanasi, Uttar Pradesh on 23rd December, 2021.
- ii. Hon'ble Prime Minister laid foundation stone of Biogas based power generation project at Dugdh Utpadak Shakari Sangh Ltd., Ramnagar, Varanasi on 23rd December, 2021.

5. Trade/International Cooperation(IC):

i. A meeting between Secretary, AHD and Mr. Ronald Verdonk, Minister-Counselor of Agricultural Affairs, American Embassy in New Delhi was held on 15th December, 2021 in Krishi Bhawan New Delhi. Market Access issues between both the countries including issues related to export of U.S. pork and bovine genetics to India were discussed during the meeting.

6. Budget:

For the year 2021-22, up to December, 2021, against the tentative Revised Estimate (RE) of Rs. 3053.53Crore, the expenditure was Rs. 2377.81Crore. During

the month of December, 2021, Expenditure for the Department of Animal Husbandry and Dairying was Rs. 291.71Crore.

7. Social Media Activities:

During the month, tweeter page of the Department was hit by 58,145 followers. Under Social Media activities 197 creative posts were made, 206 tweets &1375 retweets were done,6 Videos& GIFs were created. Facebook of the Department had 1, 26,270 followers.
