Important policy decisions taken and major achievements during the month of June, 2021.

1. Cattle & Dairy Development:

- i. 7thCentral Project Steering Committee (CPSC) meeting was held on 11.06.2021 along with Officers of NDDB & National Cooperative Development Corporation (NCDC) to review the progress and take certain decisions for smooth implementation of Dairy Infrastructure Development Fund (DIDF) scheme.
- ii. A review meeting was held with Secretary (Labour and Employment) for finalizing the details regarding early launch of pension scheme for dairy farmers under Pradhan Mantri Shram Yogi Maan-dhan (PM-SYM).
- iii. A webinar was organized by the Department in collaboration with Ministry of Food Processing Industries (MoFPI), GoI on 16.06.2021 & 17.06.2021 on PM Formalization of Micro Food Processing Enterprises Scheme (PM-FME) of MoFPI to create awareness among stakeholders of the animal husbandry and dairy sector across the country.

2. 2. Livestock Health:

i. The outbreak of Avian Influenza (H5 and H5N8) in poultry / ducks was confirmed in the States of Kerala, Haryana, Maharashtra, Madhya Pradesh, Chhattisgarh, Punjab, Gujarat, Jammu & Kashmir and Uttar Pradesh. The Avian Influenza was also confirmed in crows / migratory birds in the States of Haryana, Maharashtra, Madhya Pradesh, Chhattisgarh, Rajasthan, Himachal Pradesh, Gujarat, Uttar Pradesh, Delhi, Uttarakhand, Jammu &Kashmir, Bihar and Punjab. The States were requested to take suitable actions as per Action plan on Prevention, Control and Containment for Avian Influenza. Post Operational Surveillance Plan (POSP) guidelines issued to the affected States. The sanitation and culling process is underway as per the action plan.

In this regard, the States are reporting to the Department on a daily basis regarding the control measures adopted by them based on the Revised Action Plan for Prevention, Control and Containment of Avian Influenza 2021. The Department continues to undertake efforts towards generating awareness about Avian Influenza (bird flu) through social media platforms like Twitter, Facebook, etc.

ii. On confirmation of incidence of Glanders in the States of Uttar Pradesh, Haryana and Madhya Pradesh, the Department communicated to the Statesto adopt Zoo sanitary measures, monitor/restrict the equine movements to and from the infected area to prevent further spread of the disease.

- iii. The Department nominated an officer for 6th Indo-Dutch Joint Working Group (JWG) meeting on Agriculture in respect of One Health and AMR.
- iv. The Department nominated officers for OIE Virtual Sub-regional Meeting: "Wildlife health networks in Asia & the Pacific" South Asia during June, 2021.
- v. One officer from LH Division of the Department attended the 1stMeeting of Standing Committee on Agriculture and Soils (SC-A&S) (under Space Application Management System).
- vi. During the month of June 2021, around 0.36 crore animals were ear-tagged against FMD.

3. National Livestock Mission (NLM)

- i. Rs. 59.00 crore was released to Credit Guarantee FundTrust for Animal Husbandry & Dairying (CGFTAHD) under the Central Sector Scheme"Animal Husbandry Infrastructure Development Fund" (AHIDF) for the year 2021-22.
- ii. Standard Operating Procedures(SOPs) for Animal Husbandry Infrastructure Development Fund (AHIDF) was prepared and uploaded on AHIDF website "ahidf.udyamimitra.in".
- iii. Two webinars were organised for probable beneficiaries of Tamil Nadu State on 11.06.2021 where FPO's, MSME and eligible beneficiaries under Animal Husbandry Infrastructure Development Fund (AHIDF) were present. A meeting with Department of Financial Services and Bankers Group was held under the Chairmanship of Secretary, AHD to review the progress of Animal Husbandry Infrastructure Development Fund (AHIDF).
- iv. A webinar was organised under the Chairmanship of Hon'ble Minister, FAHD on 21.06.2021on self-sustainable Goshalas.

4. Credit, Extension and Publicity (CEP):

The Department organized a virtual event for the Celebration of "World Milk Day" on 1st June, 2021. The virtual event was inaugurated by the Hon'ble Minister for Fisheries, Animal Husbandry and Dairying and Hon'ble Minister announced for inviting nominations of National "Gopal Ratna Awards" for the year 2020-21 and Integration of e-Gopala with UMANG. A Technical Session on "Role of Breed Improvement Technologies in Genetic Upgradation Programme" was also held during this event. Field staff and dairy farmers associated with ICAR, State and Central institutions actively participated in the event which was live streamed through Facebook.

5. Virtual Regional Review Meetings were organized during 08.06.2021 to 10.06.2021 under the Chairmanship of Secretary, AHD with Principal Secretaries/Secretaries/Directors/nodal schemes officers of States/UTs in order to apprise States/UTs about the way forward for next 5 years and to take stock of implementation of ongoing schemes of the Department.

6. Budget:

For the year 2021-22, up to June, 2021, against the Budget Estimate (BE) of Rs. 3599.98 Crore, the expenditure was Rs. 376.03 Crore. During the month of June, 2021, Expenditure for the Department was Rs. 284.76 Crore.

7. Social Media Activities:

During the month, tweeter page of the Department was hit by 46,391 followers. Under Social Media activities 177 creative posts were made, 286 tweets&1728 re-tweets were done,9 Videos & GIFs were created. Facebook of the Department had 1,23,876 followers. Koo account of the Department has 28,692 followers. The Department has opened an account on Instagram.
