# **Rashtriya Gokul Mission**

## **The Scheme**

Rashtriya Gokul Mission is a sub scheme of 'Development Programme'. It has been revised and re-aligned and its duration is from 2021-22 to 2025-26.

## Scope and Area of Operation

Implemented throughout the country and all Components as mentioned in the guidelines are eligible for funding

## Objectives

To enhance productivity of bovines and increasing milk production in a sustainable manner using advanced technologies

To enhance Artificial Insemination coverage through strengthening the breeding network and delivery of Artificial Insemination services at the farmers' doorstep To propagate use of high genetic merit bulls for breeding purposes.

To promote indigenous cattle & buffalo rearing and conservation in a scientific and holistic manner.

## **Funding Pattern**

100% grant-in aid from Government of India for all components of the Scheme except for :

- a) 50% capital subsidy to eligible entrepreneurs, individuals, SHGs, FPOs, FCOs, JLGs and Section 8 companies for establishment of Breed Multiplication Farms.
- b) 50% subsidy to farmers for use of sex sorted semen, and
- c) Subsidy of Rs. 5,000 for farmers getting assured pregnancy using IVF.

State Livestock Development Boards\* / State Milk Federations\* / CFSP&TI, CCBF, CHRS, NDDB / ICAR / ICAR Institutes

\*State Government may decide on the State Implementing Agency and participating agencies of the scheme

#### **Salient Features**

Scheme provides for funding for:

- a) Breed Improvement:
  - (i) Strengthening of semen stations;
  - Bull Production Programme : Progeny Testing, pedigree selection, genomics, accelerated breed improvement programme (IVF technology);
  - (iii) Establishment of Breed Multiplication Farms.

b) Extension of AI Coverage :

- (i) Nationwide AI programme;
- (ii) Establishment of MAITRIs;
- (iii) Accelerated Breed Improvement Programme (Sex Sorted Semen);
- c) Development and Conservation of Indigenous Breeds
- d) Skill Development- Training of professionals; Al technicians etc.
- e) Organising Farmers' awareness programmes.

#### Target Group / Beneficiaries and Benefits

Dairy Farmers irrespective of caste, class and gender.

- (i) Free-of-cost AI services at the farmers' doorstep under NAIP.
- (ii) About 1.5 crore farmers will be benefitted under NAIP and income of the farmers will increase by Rs. 21,500 annually after three years.
- (iii) Subsidy of Rs. 5,000 per assured pregnancy is available to farmers under Accelerated Breed Improvement Programme (ABIP) using IVF technology.
- (iv) Income of farmers participating in ABIP using IVF technology will increase by Rs. 60,000 per annum after 3 years.

The Implementing Agencies (IAs) will formulate proposals as per the Guidelines of the scheme. Detailed Project Report should be submitted to DAHD through the concerned State Governments.

- (v) Subsidy of Rs. 750 to farmers for getting assured pregnancy using sex sorted semen.
- (vi) Subsidy of Rs. 2 crore for establishment of breed multiplication farm in Hub and spoke model.



### Procedure for applying

Central Agencies / NDDB / ICAR will submit proposals directly to DAHD. Funds under the scheme will be released directly into the accounts of IAs through PFMS.
