

2. It is to be noted that the above are only indicative allocations and are subject to modifications and changes according to Regular Budgetary Allocations for 2019-20 and also taking into account the pending unspent balances for States / UTs.

3. The State Government may ensure that, 16.6% of budget allocations be made specifically for Scheduled castes under the SCPSC component and 8.6% for scheduled tribes under the TSP component.


4. Similarly for women beneficiaries and physically challenged/ differently-abled persons efforts may be made to cover 30% and 3% of the budget allocation respectively, as far as possible.

5. If viable proposals are not received from all States / UTs within the first quarter of the Financial Year, this Department / NABARD may re-allocate the funds between States / UTs having more demand.

6. Department of Animal Husbandry, Dairying and Fisheries reserves the right to modify, add, delete any term / conditions without assigning any reason and its interpretation of various terms will be final. Department of Animal Husbandry, Dairying and Fisheries reserves the right to recall any amount given under the scheme without assigning any reason thereof.


