


TERMS & CONDITIONS:-

- 1 Work will be executed as per specification 2009 and works manual of CPWD and as per direction of engineer in charge.
- 2 1% water and 1% electric charges (if electricity/water used) will be recovered from the gross amount of bill if the work is executed within DMS Premises.
- 3 Running payment will be made only after execution of 30 % work.
- 4 Rate so approved will be valid up to one year from the date of award of work
- 5 Further work can be awarded as and when required, for which a separate work order will be issued on the basis of approved rate, term and conditions after execution/completion of present/current contract/work
- 6 No any escalation will be considered in respect of hike in prices of labour and materials till the rate is valid/work completed
- 7 All the term and conditions clauses of the NIT and manual of CPWD & form 7/8 will be followed for contract / agreement as they stand or as may be altered from time to time
- 8 They shall employ the required technical staff and tools and plants as per term and conditions of contract
- 9 General Manager, Delhi Milk Scheme shall reserve right to reject any or all tenders without assigning any reasons and decision of GM(DMS) shall be final and binding
- 10 In case of any dispute the matter shall be referred to arbitrations of sole Arbitrator to be appointed by G.M. (DMS)
- 11 First class brick will be used instead of class designation 75 bricks/as approved by Engineer in charge.
- 12 No any extra payment will be made for any hidden item and work deviation limit 20% will be allowed only as mentioned in clause 12



- 13 Work will be executed within 30 days after seventh day of issue of work order / award letter, failing which a penalty of Rs. 300/per day will be deducted from the bill, but not exceeding 10% of the value of the work awarded.
- 14 Earnest money of Rs.1000/- in the shape of DAC in favour of General Manager DMS of a scheduled bank to be deposited, without earnest money quotation/tender will not be considered.
- 15 Contractor shall have to deposit 5% performance guarantee amount of tendered amount within 15 days of award on contract for the performance of contract in the shape of DD/DAC/ FDR in favour of General Manager, DMS or cash in cash section of DMS. The same will be refunded after successfully completion of contract period and submission of a No Demand Certificate.
- 16 The party may physically examine /inspect the site/scope of work and also go through the term and conditions of tender before quoting their rates.
- 17 Rate may be quoted exclusive good and service Tax (GST) and firm should have GST registration certificate (GST will be paid extra)
- 18 Tenderers/ bidders shall provide/ enclosed the photo copy of PAN Card and residence proof along with tender
- 19 The contractor is required to abide by all statutory requirement as per Law applicable during the contract period
- 20 In case of any hardship/operation problems faced by either (i.e. contractor or DMS).General Manager, DMS have the right to add/ modify any conditions in the public interest by recording reason to this office.
- 21 The said contract can be short closed/cancelled at any time without assigning any reason at the sole discretion of General Manager ,Delhi Milk Scheme
- 22 Your Tender offer should be valid for a period of 90 days from the closing date of tender
- 23 All disputes arising out of or touching on the contract shall be subjected to the jurisdiction of the court of Union Territory of Delhi only.

- b. All bidders/tenderer should sign the tender document at appropriate place. Unsigned tender shall not be considered/ accepted


