1. Goods & Service Taxes: Goods & Service Tax shall be paid by DMS on production of documentary evidence.

- 7. Payment Terms: The payment shall be made on quarterly basis and on submission of bills duly certified by SDE/DE to AO (I)/Store Payment for arranging payment. TDS will be deducted, if applicable.
