- Applications shall be submitted within 45 days from the date of <u>actual</u> <u>disbursement</u> of the working capital loan and should include the copy of sanction letter and disbursement letter of Bank/FI for working capital loan/cash credit from financial institutions.
- Following documents need to be submitted to the NDDB along with the application form.
  - > Sanction letter of the Working Capital Loan along with terms and conditions, disbursement letter and copy of loan agreement".
