**Subject: Release of subsidy amount under National Livestock Mission Entrepreneurship Development Project (NLM EDP) to Small Industries Development Bank of India (SIDBI) during the year 2021-22.**

Sir,

I am directed to convey the sanction of the President of India for payment of **Rs. 16.4153 Crore (Rupees Sixteen Crore Forty one Lakh Fifty Three Thousand only)** under the Central Sector Scheme "National Livestock Mission Entrepreneurship Development Project" (NLM EDP) as First Installment of 50% capital subsidy for the year 2021-22 to **Small Industries Development Bank of India (SIDBI)** as per Cabinet approval of the scheme and para 5.1 of the operational guidelines of National Livestock Mission .

2. It is requested that the sanctioned amount of **Rs. 16.4153 Crore (Rupees Sixteen Crore Forty one Lakh Fifty Three Thousand only)** may please be paid by RTGS to **Small Industries Development Bank of India (SIDBI)** to provide capital subsidy to the entrepreneurs as first installment for the projects sanctioned under NLM EDP during 2021-22 as per the table annexed.

3. The expenditure will be debited to:

**Demand No. 42 : Department of Animal Husbandry & Dairying**  
**Major Head 2403 : Animal Husbandry**  
**00103 : Poultry Development**  
**26 : Development Programme**  
**01 : National Livestock Mission**  
**260131 : Grant-in-aid-General**

4. This amount is paid to SIDBI for onward transmission to loan account and/or bank account of eligible beneficiaries approved under the NLM EDP as per the table annexed within a period of one month from date of release of amount.

5. Funds being released by Government of India are to be managed and utilized by SIDBI for providing capital subsidy under "National Livestock Mission Entrepreneurship Development Project" in accordance with operational guidelines of National Livestock Mission during the year 2021-22.

6. As per scheme guidelines 50% of proposed capital subsidy will be released as the first installment at the beginning of the project and rest of the subsidy amount will be released as second installment after completion of the project. The total actual capital investment will be checked by SIA for calculation of eligible subsidy amount while providing completion certificate and recommending for release of second installment..

7. This release is further subjected to the following terms and conditions of General Financial Rules-2017.

a) In terms of rule 236(1) of General Financial Rules, 2017, the account of Grantee Institutions or organizations shall be open to inspections by the sanctioning authority and audit both by the

Comptroller and Auditor General of India and under the provision of CAG (DPC), 1971 and under audit by the Principal Accounts Office of the Department, whenever the Institution/Organization call to do so.

- b) The Banks shall submit an audited certificate of actual utilization subsidy sanctioned in prescribed Proforma (GFR-12 A) specifying report on targets and achievements cum performance report in terms of rule 212 (3) General financial Rule, 2017 to the sanctioning Authority.
- c) Performance-cum-Achievement report should also be submitted after utilization of this amount.
- d) The assets acquired wholly or substantially out of the Government funds, except those declared as obsolete and unserviceable or condemned in accordance with the procedure duly laid down in GFR, shall not be disposed of without obtaining the prior approval of authority which sanctioned the grant.

8. Department of Animal Husbandry & Dairying reserve the rights to modify, add and delete any terms/conditions without assigning any reasons and its interpretation of various terms will be final. It also reserves the right to recall any amount given under the scheme without assigning any reason thereon.

9. Any other operational instructions issued by DAHD, GOI from time to time will be strictly followed.

10. The SIDBI is also requested to ensure registration of all the beneficiaries till last levels and use of Expenditure, Advance and Transfer (EAT) module of Public Financial Management System (PFMS) for flow of funds so that effective monitoring of funds utilization can be done as per the Rule 232 (v) of GFR, 2017.

11. A statement indicating the status of the funds available with the designated banks with regard Animal Husbandry and Dairying need to be submitted to GOI on monthly/quarterly.

12. Drawing & Disbursing Officer (DDO) of the ministry is authorized to prefer the bill to the Pay & Accounts Officer for the releases of Rs. 16.4153 Crore (Rupees Sixteen Crore Forty one Lakh Fifty Three Thousand only) to **Small Industries Development Bank of India (SIDBI)** through RTGS as per the Bank details given below.
