3. **Manual offer** shall not be accepted.

4. **Offer Validity:** your offer should be valid for a period of 90 days.

5. **Bid Security Declaration :**All bidders are required to furnish "**Bid Security Declaration**" accepting that if they withdraw or modify their bids during a period of validity etc., they will be suspended for the time for one year.

SPECIFICATION C Mono Carton for PACKING of 500 gm. Table Butter (STB and WTB) ANNEXURE

I. Board Specification-Duplex board of specified grammage, uniform thickness, free from hole, hard spots and lumps shall be used for the cartons. The board shall be clean and free from loosely bound fibers and loading.

II. Slitting and Cutting-The cartons shall be cut cleanly and exactly as per specified dimensions. All cut edges shall be entirely free from loose fibers and dust. The side flaps which are to be glued shall be punched with serrations for better pasting.

III. Fold Ability -The liner should not exhibit any cracking when the board is folded and creased.

IV. Moisture Content: Moisture content of carton shall not exceed 5% maximum by weight.
