**Subject: 'E' tendering for purchase of 200 MT Skimmed Milk Powder by Delhi Milk Scheme.**

Delhi Milk Scheme is Central Government Organization under Department of Animal Husbandry & Dairying, Ministry of Fisheries, Animal Husbandry & Dairying, GoI, engaged in supplying high quality milk and milk products to the citizens of National Capital and **intends to purchase the following material from State Dairy Federations, NDDB/ Mother Dairy & Govt. sources only.**

- On Line Rates/ Offer** : Your consolidated online rates / offer for complete quantity of 200 MT Skimmed Milk Powder for supply to this office, price payable per kg **F.O.R. DMS Godown** (including taxes, transportation, insurance, loading/unloading etc) along with delivery schedule should be uploaded well before the closing date of e-tender. It will be mandatory for parties to quote a single rate/ offer for complete quantity of 200 MT SMP after considering the individual rate of each 100 MT SMPs with different manufacturing dates. **Parties failing to quote single rate for complete 200 MT SMP will not be considered eligible for this tender and their tender offer shall be rejected summarily.** Manual offer shall not be accepted.
- Offer Validity**: Your offer / rate should be valid upto 25.06.2021.
- Product Quality** : Skimmed Milk Powder should be manufactured as per the manufacturing dates mentioned for each of the 100 MT SMP at point no. 1 above and quality of product should be as per BIS Certified. As regards testing for details analysis of above SMP, DMS may send sample to notified third party laboratory as per DMS order no. 3-2/2020-SPH/23 dated 15.01.2021. In such events test results shall be intimated to the successful bidders. Successful bidder may opt to witness the analysis procedure
- Quality Inspection** : Pre delivery inspection may be carried out by DMS Quality Control Team before supply of consignment as per DMS requirement. However, final inspection shall be carried out at Delhi Milk Scheme and/ or notified third party laboratory which shall be considered final. In case of rejection, party is required to replace the rejected consignment without any extra charge.

6. **Quantity** : DMS shall have the option to increase/decrease the above quantity upto 50% at the same rates, terms & conditions of this e-tender. However, it is compulsory for bidders to offer the complete quantity of SMP as per tendered quantity i.e. 200 MT SMP with single rate only, failing which their bid shall be treated unresponsive and shall be rejected summarily.
7. **Delivery Period** : Delhi Milk Scheme being Central Govt. Organization is supplying milk & milk products to the Parliament of India, Hospitals, Defence Installation, institutions etc. Hence Delivery Period is the essence of the contract/ purchase order which must be adhered to. As per requirement of DMS, the delivery schedule of each 100 MT SMP with different manufacturing dates as mentioned at point no. 1 is as follows:
- (c) First 100 MT consignment which is manufactured not before November, 2020 is to be supplied by party to DMS in the month of August 2021 i.e., during the period from 1st August to 31st August, 2021.
- (d) Remaining 100 MT consignment which is manufactured not before April, 2021 is to be supplied by party to DMS in the month of November 2021 i.e., during the period from 1st November to 30th November, 2021.
8. **Tender Opening**: Tender Enquiry containing terms & conditions can be downloaded from Central Public Procurement – Portal website i.e. [eprocure.gov.in/eprocure/app](http://eprocure.gov.in/eprocure/app) from **03.06.2021** to **14.06.2021** (upto **2:00 PM**). Your online Tender offer along with terms & conditions of this e-tender **shall be accepted upto 2:00 PM on 14.06.2021 and shall be opened next day at 2:00 PM on 15.06.2021**. Scanned copy of your Tender Offer along with signed copy of this e-tender (.pdf) by accepting all the terms and conditions of this tender and Financial Bid in (.xls) file may be uploaded / placed appropriately on aforesaid CPP-Portal before due date & time. No manual rate offer shall be accepted.
