Subject: 'E' tendering for purchase of 400 MT Skimmed Milk Powder by Delhi Milk Scheme.

Delhi Milk Scheme is Central Government Organization under Department of Animal Husbandry & Dairying, Ministry of Fisheries, Animal Husbandry & Dairying engaged in supplying high quality milk and milk products to the citizens of National Capital and **intends to purchase the following material from State Dairy Federations, NDDB, Mother Dairy & Govt. sources only.**

1.	Skimmed Milk Powder manufactured not before July, 2019 & as per BIS certified.	400 MT

2. **On Line Rates/ Offer** : Your **online rates / offer** indicating the quantity of Skimmed Milk Powder for supply to this office, price payable per kg **F.O.R DMS Godown** (including taxes, transportation, insurance, loading/unloading etc) along with delivery schedule should be uploaded well before the closing date of e-tender. **Manual offer shall not be accepted.**

3. **Offer Validity**: Your offer / rate should be valid upto **15.01.2020**.

4. **Product Quality** :Skimmed Milk Powder should be manufactured not before July, 2019 and as per BIS Certified.

5. **Quality Inspection** : Pre delivery inspection may be carried out by DMS Quality Control Team before supply of consignment as per DMS requirement. However, final inspection shall be carried out at Delhi Milk Scheme and shall be considered as final.

6. **Quantity** : DMS shall have the option to increase/decrease the above quantity upto 50% at the same rates, terms & conditions. **However, it is compulsory for bidders to offer at least 75% of tendered quantity (i.e. 300 MT SMP), failing which, their bid shall be treated unresponsive and will be rejected summarily.**

7. **Delivery Period** : Delhi Milk Scheme being Central Govt. Organization is supplying milk & milk products to the Parliament of India, Hospitals, Defence Installation, institutions etc. Hence Delivery Period is the essence of the contract/ purchase order which must to be adhered to.

8. **Tender Opening**: Tender Enquiry containing terms & conditions can be downloaded from Central Public Procurement – Portal website i.e. **eprocure.gov.in/eprocure/app** from **24.12.2019** to **03.01.2020** (upto **14:00 PM**). Your online Tender offer along with terms & conditions **shall be accepted upto 14:00 PM on 03.01.2020 and shall be opened next day at 14:00 PM on 04.01.2020**. Scan copy of your Tender Offer (.pdf) mentioning terms and conditions and Financial Bid in (.xls) file may be uploaded / placed appropriately on aforesaid CPP-Portal before due date & time. No manual rate offer shall be accepted.
