Delhi Milk Scheme is Central Government Organization under Department of Animal Husbandry & Dairying, Ministry of Fisheries, Animal Husbandry & Dairying, GoI engaged in supplying high quality milk and milk products to the citizens of National Capital and **intends to purchase the following material from State Dairy Federations, NDDDB, Mother Dairy & Govt. sources only.**

- On Line Rates/ Offer** : Your **online rates / offer** indicating the quantity of White Butter for supply to this office, price payable per kg (for 82% Fat on pro – rata basis) **F.O.R. DMS Godown** (including taxes, transportation, insurance, loading/unloading etc) along with delivery schedule should be uploaded well before the closing date of e-tender. **Manual offer shall not be accepted.**
  - Offer Validity** : Your offer / rate should be valid upto **05.09.2020.**
  - Product Quality** : White Butter should be as per BIS Standards made from mixed milk and manufactured not before February, 2020.
  - Quality Inspection**: Pre delivery inspection may be carried out by DMS Quality Control Team before supply of consignment as per DMS requirements. However, final inspection shall be carried out at Delhi Milk Scheme and shall be considered as final.
  - Quantity** : DMS shall have the option to increase/ decrease the above quantity upto 50% at the same rates, terms & conditions. However, it is compulsory for bidders to offer at least 150 MT of White Butter against tendered quantity, failing which, their bid shall be treated unresponsive and will be rejected summarily.
  - Delivery Period** : Delhi Milk Scheme being Central Govt. Organization is supplying milk & milk products to the Parliament of India, Hospitals, Defence Installation, institutions etc. Hence Delivery Period is the essence of the contract / purchase order which must to be adhered to.
  - Tender Opening** : Tender Enquiry containing terms & conditions can be downloaded from Central Public Procurement – Portal website i.e. **eprocure.gov.in/eprocure/app** from **05.08.2020** to **19.08.2020** (upto 14.00 PM). Your online tender offer alongwith terms & condition shall be accepted upto 14:00 PM till 19.08.2020 and shall be opened next day on **20.08.2020 at 14:00 PM**. No manual rates offer shall be accepted. 
