Delhi Milk Scheme is Central Government Organization under Ministry of Agriculture & Farmers Welfare engaged in supplying high quality milk and milk products to the citizens of National Capital and intends to purchase the following material from State Dairy Federations, NDDB, Mother Dairy and other government sources only.

- 2. On Line Rates/Offer: Your online rates / offer indicating the quantity of White Butter offered for supply to this office, price payable per kg F.O.R. DMS Godown (including taxes, transportation, insurance, loading/unloading etc) along with delivery schedule should be uploaded well before the closing date. Manual offer shall not be accepted.
- 3. Offer Validity: Your offer / rate should be valid upto 20.04.2022
- 4. <u>Product Quality</u>: White Butter should be as per FSSAI Standards made From Mixed Milk and manufactured not before October, 2021. The White Butter consignment dispatched to DMS must ensure following quality norms:
 - (a) Consignment of white butter at the time of sampling of white butter at DMS should be in the order of standards laid down under FSSAI. The products should preferably be brought to DMS under refrigerated condition maintaining cold chain throughout the transportation period. This manner of transportation should enable butter to be found at Sub- Zero temperature at least, at the time of sampling at DMS.
 - (b) Butter cartons stained with butter will not be accepted.
 - (c) As regards testing for details analysis of above White Butter may send sample to notified third party laboratory as per DMS order no. 3-2/2020-SPH dated 15.01.2021. In such events test results shall be intimated to the successful bidders. Successful bidder may opt to witness the analysis procedure.
- Quality Inspection: Pre delivery inspection may be carried out by DMS Quality Control Team before supply of consignment as per DMS requirements. However, final inspection shall be carried out at Delhi Milk Scheme and / or notified third party laboratory which shall be considered final. In case of rejection, party is required to replace the rejected consignment without any extra charge.

- 6. Quantity: DMS shall have the option to increase/ decrease the above quantity upto 50% at the same rates, terms & conditions. However, it is compulsory for bidders to offer the complete quantity of White Butter as per tendered quantity, failing which, their bid shall be treated unresponsive and will be rejected summarily. Quantity in each batch manufactured should not be less than 2 MT
- 7. <u>Delivery Period</u>: Delhi Milk Scheme being Central Govt. Organization is supplying milk & milk products to the Parliament of India, Hospitals, Defence Installation, institutions etc. Hence Delivery Period is the essence of the contract / purchase order which must to be adhered to.
- 8.
