- V. **Tenure:** As per the directions of CVC, the appointment as IEM is for a period of three years only, with immediate effect.
- VI. **Transport:** Reimbursement of conveyance charges on the same terms and conditions as admissible to any serving officer of equivalent rank under the Delegation of Financial Rules.
