PUBLIC AUCTION NOTICE


It is hereby notified for general information of the public that the Tamarind Fruits CEAH (CCBF-60 trees, RFS-50 trees & CPDO&TI-25 trees) will be disposed through public auction on **08.02.2024 at 11.00am** at the CCBF Hesaraghatta Premises.

TERMS AND CONDITIONS

1. The bidder should **SUBMIT SELF ATTESTED AADHAAR COPY** and deposit in Cash a sum of Rs.10,000/- (Rupees Ten Thousand Only) as Earnest Money Deposit (EMD), which will be refunded after the completion of auction procedures (except successful bidder). Only 01 bidder will be allowed inside the farm after issuing Tokens for auctioning and all others shall stay out of the farm. Without Aadhaar copy no person will be allowed to bid. No relatives/friends should accompany the bidder.
NOTE: Tokens issued to one party should not be swapped or exchanged with other party, otherwise EMD will not be refunded. Also EMD will not be refunded during auction process.
2. Intending bidder may inspect the fruit bearing trees on any working day between 9.30am to 5.00pm till 07.02.2024 **with prior permission of the undersigned/ Section Incharge.** Kindly note **no trespassing is allowed in the Farm/Residential Quarters before/during or after auction process.**
3. It will be an open bidding system where the bidder calling the highest bid/rate will be accepted.
4. If any bidder or any outsider damages life/ property of this farm, then he will be barred from entering the farm and will not be allowed to participate in future auctions of this farm.
5. The fruits once auctioned cannot be taken back on exchange.
6. The **rate quoted in auctioned bid whichever is found higher will be accepted.**
7. The successful bidder should remit immediately the Sales value along with the Sales Tax, if applicable, and submit a copy of Sales Tax Receipt to this office before taking delivery, failing which the EMD will be forfeited and tender amount or Bid accepted in his favour will be cancelled.
8. The successful bidder has to take permission of Admin Office/ Livestock Section incharge on each time before engaging labours for the harvest and collection tamarind fruits. He shall **SUBMIT A COPY OF AADHAAR CARD AND ALSO A WRITTEN UNDERTAKING** to the undersigned (asking permission to collect) along with a self attested copy of his/ his authorized representative's Aadhaar card with full contact details without which he would not be allowed to take the delivery.
9. The successful bidder shall be responsible for any damage etc caused to the farm properties in the process including the said Tamarind trees. The amount of damages, if any, shall be recovered from EMD, which will be released after receiving Clearance Certificate from the Section Incharge/Office.
10. All labour and other charges related to watch and ward, plucking of fruits, collection, storage, transportation, etc will be borne by the successful bidder. The successful bidder will have no right for anything except collection of tamarind fruits before 31.03.2024.
11. Neither the bidder nor his family/friends/labour are allowed to stay in the farm premises during or after the collection of fruits.
12. The right to collection tamarind fruits will cease upto **5.00pm on 31.03.2024**. This farm is not liable for loss/damages caused to the said fruits of this farm and its residential campus.
13. If the amount is found less than the reserved price the auctioned bid or in the quotations, any bid or all the bid/quotations can be cancelled by the HoD CEAH without assigning any reasons and the decision of the officer will be final and binding.
14. The right to accept or reject any bid is reserved with the Head of Department, CEAH, Hesaraghatta, Bangalore, without assigning any reason.
