**Important policy decisions taken and major achievements during the month of December, 2023.**

**1. Cattle & Dairy Development:**

Progress of ongoing Nation-wide AHD KCC Campaign was reviewed by Additional Secretary (CDD) on 12.12.2023. The review meeting was attended by senior officers from DFS, NABARD, State AHD Department, Milk Federations and SLBC Convenors.

**2. Livestock Health:**

- i. The Department is augmenting the efforts of States/UTs for timely control and containment of LSD and to prevent further spread of disease. The disease is presently under control and vaccination as per the guidelines is underway and more than 10.15 crore cattle have been vaccinated during 2023.
- ii. The Department is financially and technically supporting States/UTs for timely control and containment of ASF and the disease is presently under control. Biosecurity and other control measures are underway as per the National action Plan.
- iii. The Department communicated to NCDC, MoH & FW regarding the animal health components of first draft of SAPRE-Meghalaya as an initiative for Rabies eradication as per National Action Plan for Rabies Eradication (NAPRE-Rabies).
- iv. The Department has submitted the proposal to Department of Expenditure, Ministry of Finance regarding Strengthening of Veterinary Infrastructure (Pashu Kalyan Samiti).
- v. The Department has submitted the proposal to Department of Expenditure, Ministry of Finance Proposal for upgradation of biocontainment facility at Chaudhary Charan Singh National Institute of Animal Health (CCSNIAH), Baghpat.
- vi. The Department has issued tentative schedule for Election of VCI Members and the process of development of software for conducting the said elections initiated.
- vii. Around 13.56 Crore doses of FMD vaccine were administered during April to December 2023. Total 4.18 Crore doses of quality FMD vaccine was made available for supply to different States in December 2023.

viii. FMD vaccination round III is completed in 12 (twelve) States namely Kerala, Andhra Pradesh, Karnataka, Tamil Nadu, Chandigarh, Puducherry, Goa, Ladakh, Maharashtra, Delhi, Odisha, and Lakshadweep. Round III is ongoing in the 18 (Eighteen) other States namely Andaman & Nicobar Islands, Gujarat, Himachal Pradesh, Jammu & Kashmir, Madhya Pradesh, Meghalaya, Punjab, Rajasthan, Sikkim, Telangana, Uttar Pradesh, Uttarakhand, West Bengal, Assam, Jharkhand, Tripura, Sikkim , DNH & DD, and Chhattisgarh. So far 14.04 Crore vaccination is done in FMD vaccination round III. Around 4.34 Cr Vaccine has been supplied Under FMD round IV to 8 (Eight) states, namely Kerala, Tamil Nadu, Maharashtra(partial), Chandigarh, Delhi, Karnataka, Puducherry, and Round IV FMD vaccination has commenced in Andhra Pradesh. Maharashtra, Karnataka& Tamil Nadu and total 2.13 Cr. animals have been vaccinated animals so far.

### **3. National Livestock Mission (NLM):**

- i. An All India Banker's Meet was organized on 30.11.2023 under the Chairmanship of Secretary, AHD for Entrepreneurship programmes of the Department (AHIDF & NLM-EDP) which are credit linked programmes to expedite the pending proposals.
- ii. A meeting under the Chairpersonship of Secretary, AHD was held to boost up the Export of Poultry Products with Government Stakeholder and Poultry Exporters on 22.12.2023.

### **4. Credit, Extension & Publicity (CEP):**

Twenty Five Awareness Programme and Fertility Camps in Aspirational districts of 3 states organized as part of the Pashudhan Jagrati Abhiyaan under Inclusive Development.

### **5. International Cooperation (IC):**

A meeting between Hon'ble FAHD Minister with a European Union delegation led by H.E. Mr. Janusz Wojciechowski, European Commissioner for Agriculture was held on 08.12.2023 to discuss issues of mutual cooperation. Market access issues between EU countries and DAHD including Market Access of Indian Buffalo meat, dairy products and pet food into EU were discussed during the meeting.

### **6. Budget:**

For the year 2023-24, up to December, 2023, against the Revised Estimate (BE) of Rs. 3717.47 Crore, the expenditure was Rs. 1476.78 Crore. During the month of December, 2023, Expenditure for the Department of Animal Husbandry and Dairying was Rs. 271.93 Crore.
