The undersigned is directed to refer to DoPT's OM No. 22-8/2024-CS.I (APAR) dated 28th March, 2024 on the subject cited above and to say that the timelines for recording of APARs at various stages as given in the table below are to be followed strictly as it has now been decided by the DoPT to introduce auto forwarding of APARs from the reporting year 2023-24 onwards. The timelines (irrespective of the ones shown on the portal) are as under:

- 3. All the officers/staff of this Department of different cadre viz. CSS, ISS, CSSS, SSS, CSCS and DAHD (Veterinary Doctors & Dairy Technical Officers) covered through 'SPARROW' Portal are, therefore, requested to strictly adhere to the time schedule for 2023-24 and get their APARs completed/recorded in time.
