

1. At present, work of Animal Welfare Board of India (AWBI) is additionally entrusted with National Livestock Mission (NLM) Division of Department of Animal Husbandry and Dairying. There is no such division as 'Animal Welfare Division' under DAHD.
2. The NLM division of DAHD has entrusted with administrative works related to AWBI and providing grant to AWBI for various activities held in AWBI.


