The post carries the pay scale of PB-3 - Rs.15600-39100+Grade Pay Rs.6600/-(pre revised) (corresponding revised pay scale of Level - 11, Rs.67700 - 208700/- Total emoluments in the minimum of the scale excluding HRA and Transport Allowance would be Rs.101550/-).

- 2. As per recruitment rules this post is to be filled by promotion/ transfer on deputation (including short term contract) from amongst the officers under the Central/ State Government/Autonomous or Statutory Organisations:
  - (i) holding analogous post on regular basis; or
    (ii) with 5 years regular service in posts in the scale of Level 10, Rs.56100-177500/- or equivalent; or
    (iii) with 8 years regular service in posts in the scale of Level 6, Rs.35400-112400/- or equivalent; and
  - (b) possessing the following qualifications and experience;
    - A. Bachelor's degree of a recognized University or Diploma in Mechanical/ Electrical/ Automobile Engineering of a recognized Institution or equivalent, with five years experience in handling dairy stores in a large dairy plant.

OR

B. Degree in Mechanical or Electrical/ Automobile Engineering of a recognized University or equivalent with three years' experience in handling dairy stores in a large dairy plant.

- C. Degree in Master of Business Administration from a recognized University/Institute or equivalent with two years specialised experience in materials management.
- 3. The Departmental Stores Officers with 5 years regular service in the grade will also be considered and in case one of them is selected for appointment to the posts, the same will be treated as having been filled by promotion.
- 4. The Departmental Stores Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.
- 5. Period of deputation including period of deputation in another excadre post held immediately preceding this appointment in the same or some other organization/ department of the Central Government shall ordinarily not exceed 3 years.
- 6.
