

**DIDF inputs for DOAHD/R/P/24/00108/2 dated 07.08.2024**

**Dairy Processing Infrastructure Development Fund:**

Central Sector Scheme which was a part of Atmanirbhar Bharat. The outlay of the scheme is of Rs 11,184 crore. The scheme was approved by CCEA on 12.09.2017 and revision was approved in CCEA on 19.02.2020.

**Provision:** The scheme envisaged for provision of interest subvention of upto 2.5% p.a. for loan on eligible components by National Bank for Agriculture and Rural Development (NABARD) through National Dairy Development Board (NDDB)/ National Cooperative Development Corporation (NCDC). Besides NABARD, NDDB were also allowed to provide loan directly to the cooperatives and milk producer companies from its own resources. Margin contribution of End Borrowers is minimum 20% and the loan component has been set up with a ceiling of 80%.

**Components of DIDF:** The scheme is being implemented to provide support to the Dairy Cooperative to create Milk Processing, Value addition & chilling facilities, Cattle feed/ feed supplement plants, Milk transportation system (Refer van/ insulated tankers etc.), Marketing infrastructure (including e-market system, bulk vending system, Parlour, deep freezer, cold storage etc., Commodity and Cattle feed go-downs, ICT infrastructure (e.g. block chain technology, servers, IT solutions, Near Real Time devices etc.), R&D (lab & equipment, new technology, innovations, product development etc.), Renewable energy infrastructure/ plants, trigen/ energy efficiency infrastructure, Pet bottle/packaging material manufacturing units for dairy purposes, Training centre (complete with civil and other necessary infrastructure)

**Eligible Entities:** Dairy Co-operative, Multi State Dairy Cooperative, Milk Producer Companies (MPC), NDDBs subsidiaries, Self Help Groups (SHGs) and Farmer Producer Organisations (FPOs) registered under State Cooperative and Companies Act.

**Way Ahead:** CCEA in its meeting dated 01.02.2024 approved DIDF to be continued under Infrastructure Development Fund (IDF) alongwith Animal Husbandry Infrastructure Development Fund (AHIDF) and now the Cooperatives are eligible to avail assistance through AHIDF.

**Progress/ Achievements:** 37 Projects from 12 States have been sanctioned by NDDB and NCDC. The financial and physical progresses (State-wise financial and physical is at Annexure-I and Annexure-II respectively) are as under:

**Supporting Dairy Cooperatives and Farmer Producer Organizations engaged in dairy activities (SDCFPO):**

**Brief description:**

This Scheme was launched during 2017-18. The scheme is being implemented through National Dairy Development Board (NDDB).

**The objective** of the scheme is to assist the Cooperative Societies and farmer producer organizations engaged in dairy activities by providing soft working capital loan to tide over the crisis on account of severely adverse market conditions or natural calamities.

Temporarily, the **component “A”** namely “working Capital loan” has been kept in suspension since inception.

Due to Economic Impact of Covid-19 on Dairy Sector, Ministry of Fisheries, Animal Husbandry and Dairying has introduced a new component “**interest subvention on Working capital loans for Dairy sector**” as the **component “B”** with an outlay of Rs 203 Cr for 2020-21. **Thus the actual implementation of scheme started during 2020-21.**

**Pattern of financial assistance:** Under the Component “B” of the scheme, an interest subvention of 2% per annum on the working capital loan is being provided to the producer owned Institutes (POIs.). Further, for prompt and timely repayment, an additional 2% per annum interest subvention is payable at the end of the loan repayment/interest servicing period.

The Union Cabinet has approved implementation of central sector scheme **Supporting Dairy Cooperatives and Farmer Producer Organizations engaged in dairy activities (SDCFPO)** as a part of Umbrella Scheme “**Infrastructure Development Fund**” from 2021-22 to 2025-26 with an outlay of Rs 500 Cr. i.e Rs. 100 crore each year. Further, as per decision of Cabinet dated 01.02.2024, it has been approved that the implementation of SDCFPO will be continued as a component of IDF with-in the approved outlay (i.e Rs 500 cr. from 2021-22 to 2025-26).

## NATIONAL PROGRAMME FOR DAIRY DEVELOPMENT

Department of Animal Husbandry & Dairying (DAHD) is implementing "National Programme for Dairy Development (NPDD)" scheme across the country since Feb-2014. The scheme has been restructured/ realigned in July 2021 for implementation from 2021-22 to 2025-26 with the following two components:

(i) **Component "A" of NPDD** focuses on creating/strengthening of infrastructure for quality milk testing equipment as well as primary chilling facilities for State Cooperative Dairy Federations/ District Cooperative Milk Producers' Union/SHGs/Milk Producer Companies/Farmer Producer Organizations.

(ii) **Component 'B' of the NPDD scheme "Dairying through Cooperatives"** aims to increase sale of milk and dairy products by increasing farmer's access to organized market, upgrading dairy processing facilities and marketing infrastructure and enhancing the capacity of producer owned institutions.

### Component A of NPDD scheme:-

## DAIRY ENTREPRENEURSHIP DEVELOPMENT SCHEME

Dairy Entrepreneurship Development Scheme (DEDS) scheme was implemented by the Department through NABARD from September 2010 to March 2020, with the objective of generating self employment opportunities in the dairy sector through enhancement of milk production, procurement, preservation, transportation, processing and marketing of milk; back-ended subsidy @ 25% of the project cost to the General Category and 33.33 % of the project cost to SC/ST category farmers and beneficiaries was provided for bankable projects. The scheme was discontinued from 01.04.2020.
