Summary of significant developments and major achievements of the Department during the month of September 2024.

### 1. Livestock Health:

No report of any major outbreak.

### I. Vaccination program - salient achievements

### i. FMD Vaccination

During the month of September 2024, around 5.09 Crore-FMD Vaccinations have been done.

Round 4 - 19.58 crore FMD vaccinations done and completed in 24 States/UTs and ongoing in 4 States.

Round 5 - so far, 4.58 crore FMD vaccinations done and completed in 3 States and ongoing in 6 State/UTs.

#### ii. Brucellosis Vaccination

During the month 16.00 lakh Brucellosis vaccinations have been done (Cumulative 4.04 crore since June, 2021)

### iii. Peste des Petits Ruminants (PPR) Vaccination

During the month of July, 80.00 Lakh PPR vaccinations have been done. (Cumulative 16.67 crore)

#### iv. CSF (Classical Swine Fever) Vaccination

During the month, total 2.66 lakh CSF vaccinations have been done. (Cumulative 59.08 lakh)

### II. Vaccination against Lumpy Skin Disease (LSD)

During 2024, there are very few incidents. Presently, only one state i.e Kerala is having 40 active cases of Lumpy Skin Disease. Total 5,16,89,457 animals have been vaccinated during 2024 and the vaccination is underway.

### III. MOBILE VETERINARY UNIT (MVU)

Overall, 4016 MVUs are operational in 28 states as on 30.09.2024 providing last mile doorstep animal health care services. During the month, 146634 no. of farmers were benefitted and 284086 number of animals were treated in 6 states.

### IV. Activities/Works related to Veterinary Council of India (VCI):

Counselling for admission to B.V.Sc & AH degree course programme (UG Program) through NEET (15 % of Seats) on all India basis for the academic session 2024-25 was scheduled 30.09.2024. However, it has been further extended up to 15.10.2024.

# V. Activities/ Works related to Chaudhary Charan Singh National Institute of Animal Health (CCSNIAH):

Completed quality control testing of 02 batch of FMD vaccines & 03 batches of PPR vaccines under LHDCP.

### 2. Dairy Division:

### I. National Programme for Dairy Development (NPDD):

Under component B of NPDD Rs. 70 Crore was released to NDDB for implementation of the scheme for the FY 2024-25.

# II. Supporting Dairy Cooperatives and Farmer Producer Organizations engaged in dairy activities (SDCFPO):

Under the SDCFPO component of IDF Scheme an amount of Rs 100 Cr was released to the implementing agency i.e. NDDB for the year 2024-25 for disbursement of interest subvention on working capital loan to cooperatives and FPO as per the scheme guidelines.

# III. Livestock Kisan Credit Card (KCC)

Hon'ble FAHD minister launched the Nation-wide AHDF KCC Campaign for the year 2024-25 on 13.09.2024 during the Monsoon Meet held at Bhubaneswar. The Campaign was continued till 31.03.2025 with the objective to provide KCC to all eligible animal Husbandry and Dairy farmers. A target of 10 lakh KCCs has been set for the said campaign.

### II. Regional Review Meeting in Bhubaneswar, Odisha

On 12.09.2024, Smt. Alka Upadhyaya chaired a Regional Review Meeting in Bhubaneswar, Odisha, attended by key officials from various eastern states. The meeting was organized to review the progress of departmental programs.

# III. Monsoon Meet 2024: National Conclave of State Animal Husbandry Ministers

On 13.09.2024, the Monsoon Meet 2024 took place in Bhubaneswar, Odisha. Chaired by Union Minister Shri Rajiv Ranjan Singh, the event brought together ministers from 17 states to foster convergence in program implementation. Key initiatives such as the National Milk Recording Programme (NMRP), the A-HELP program, and a nationwide Kisan Credit Card (KCC) campaign were launched. The event emphasized improving livestock health and livelihoods through government action plans and technology integration.

Discussions were held on how to expedite progress as well as expenditure. The States showcased their new initiatives.

### IV. Media Briefing on 100 Days of Ministry Achievements

On 17.09.2024, Union Minister Shri Rajiv Ranjan Singh briefed the media on the ministry's accomplishments within the first 100 days of Prime Minister Narendra Modi's third term. The press conference highlighted major initiatives in fisheries, animal husbandry, and dairying.

### V. Participation in 8th India Water Week 2024

The Department of Animal Husbandry and Dairying participated in the 8th India Water Week exhibition from 17.09.2024 to 20.09.2024 at Pragati Maidan, New Delhi. The department showcased its contributions to reducing water footprints in livestock and poultry production, aligning with Sustainable Development Goal 6. The event emphasized partnerships for inclusive water management and featured global stakeholders, policymakers, and innovators in water resource management.

### VI. Participation in World Food India 2024

The Department of Animal Husbandry and Dairying participated as a partner ministry in the World Food India 2024 event held at Bharat Mandapam, New Delhi. The department's pavilion, inaugurated by Secretary Smt. Alka Upadhyaya on 19.09.2024, showcased major schemes, innovations, and new technologies in the livestock and dairy sectors. Union Minister of State Prof. S.P. Singh Baghel launched new products developed by startups during the event. The pavilion featured live demonstrations and stalls from startups, with a focus on promoting technological advancements. Additionally, a knowledge session on youth entrepreneurship in the livestock sector was held.

### 5. National Livestock Mission

The DAHD has signed the MoU with an NGO named as TRIF working with MoRD for awareness creation for the schemes of DAHD amongst the SHG beneficiaries. Three Webinar have been held where more than 35000 Participants were educated on DAHD entrepreneurship Programme, submission of applications, total NLM scheme, Fodder development programme, Livestock Insurance programme, NADCP scheme, involvement of Pashushakis in vaccination programme, vaccination of various livestock diseases and their remedies, zoonotic diseases and AHIDF also.

# 6. Expenditure

Overall Rs 533.22 (provisional) was incurred in the month of September 2024 as compared to Rs 217.59 (provisional) expenditure incurred in the month of August 2024.

### 7. Grievance disposal:

261 grievances were brought forward, 356 received during the month and 432 disposed of in respect of Department of Animal Husbandry and Dairying under CPGRAM portal.
