Will the Minister of FISHERIES, ANIMAL HUSBANDRY AND DAIRYING

मत्स्यपालन, पशुपालन और डेयरी मंत्री

be pleased to state:

- (a) whether the demand for animal products, such as milk, meat, and eggs is growing faster than plant-based foods due to rising income and changing food habits which made livestock husbandry more lucrative than crop farming, if so, the details thereof;
- (b) the details of long-term growth trajectories of the crops and livestock sectors bear this out because the average Compound Annual Growth Rate (CAGR) of crop production (at constant prices) has plummeted from 3.0 per cent in the 1950s to 1.5 per cent in the last decade, that of livestock has shot up from 3.0 per cent to nearly 7.5 per cent;
- (c) whether the share of crops in agriculture and its allied sectors' Gross Value Added (GVA) has also been decreasing steadily and in the past decade alone, it shrank from 65.4 per cent to 55.1 per cent; and
- (d) if so, the details thereof till now?

**ANSWER**

- (a) & (b) Yes Sir. As per the estimation made by working group on “**Demand & Supply Projections Towards 2033**” of NITI Aayog, the demand of animal products such as milk, egg and other non-veg items like fish, egg and meat has estimated to increase to 33%, 47%, 31%, respectively in 2021-22 over 2011-12.
- (c) & (d) Yes Sir. Year-wise the share of crop production in agriculture and its allied sectors' Gross Value Added (GVA) is given at **Annexure - I**.
