Report on Situation Analysis of Semi-finished Loose Ghee, Packed Ghee and White Butter of DMS 20 September, 2024

NDDB had received a request from Joint Commissioner (DD), DAHD to conduct a situation analysis with regard to semi-finished loose ghee, packed ghee and white butter of Delhi Milk Scheme (DMS) stored at Central Dairy-DMS, West Patel Nagar-New Delhi. In line with the above request, a team comprising Shri Manoj Rajput, Sr. Manager (QA), Dr Pankaj Sherasia, Sr. Manager (PE-AN) and Shri Naveenkumara AC, Manager (QA) visited Central Dairy-DMS on 20th September, 2024.

During the visit, discussion was held with Shri Chinmoyjit Sen, GM-DMS. GM informed that about 26.93T of unutilized Ghee and Butter is stored in Central Dairy. He also informed that the products were manufactured/packed in the month of Sep/Oct 2023.

Shri ML Birwa, Section Manager-Production and Shri Chetan Prakash, Sr. Lab Analyst from DMS were also present during the inspection and sampling.

Product Storage

• Ghee

- 5200 kg ghee in the settling/storage tanks was stored at ambient temperature. The ghee had rancid / off flavor. The ghee may be analyzed for peroxide value in addition to FSSR requirements. The ghee was partly solidified.
- 719 kg ghee in milk cans was stored in cold room at a temperature between 9-10°C. The ghee was solidified.
- 11754 kg ghee pre-packed in 1liter pouches was stored in cold room at a temperature between 5-10°C. The packed ghee was stored/stacked based on date of packaging (7-12 October 2023) and had declared best before as '10 months from date of manufacture when stored at or below 9°C'. The ghee was solidified.
- Some images indicating storage conditions of ghee are provided in *Annexure-1*.

• Butter

- 6550 kg white butter (25kg blocks wrapped in polyfilm) was stored in crates in deepfreeze at -11°C.
- 2106 kg unpacked retail white butter (500g) wrapped in milk poly-film was stored in crates (20kg in each crates) in deepfreeze at -11°C.
- The product is not in standard packaging and in contact with the crates. It was observed that the crates were stored along the wall leaving no space between product stack and wall in deepfreeze.
- There was no visual mold growth /infestation observed on butter surface.
- Some images indicating storage conditions of butter are provided in *Annexure-1*.

Sample Collection

- Ghee
 - Ghee in the settling/storage tank and milk cans:

A homogenous mixture of the product was made by mixing with the help of plunger. A representative sample was drawn from each tank separately. For the ghee in milk cans, a composite sample was drawn. The details of the samples drawn are provided in the table below.
