**Summary of significant developments and major achievements of the Department during the month of November, 2024.**

- I. The Department of Animal Husbandry and Dairying (DAHD) celebrated **National Milk Day 2024** on 26.11.2024 at New Delhi, commemorating Dr. Verghese Kurien's 103rd birth anniversary. Hon'ble Union Minister Shri Rajiv Ranjan Singh alias Lalan Singh and Hon'ble Ministers of State Prof. S.P. Singh Baghel and Shri George Kurian presided over the event, recognizing dairy's contribution to the economy and farmers. National Gopal Ratna Awards were presented, including special awards for winners from the North Eastern Region.

Amul Clean Fuel Rally had been flagged off on 19.11.2024 by the Hon'ble Union Minister of Home Affairs and Cooperation from Himmat Nagar in Sabarkantha district of Gujarat. Amul Clean Fuel Rally celebrated dairy's transformational role, showcasing its achievements and potential in utilizing Bio CNG for motor vehicles. The Amul Clean Fuel Rally collectively covered over 5,000 kilometers, traveling from Himmat Nagar in Gujarat, Kolkata, Pune, and Jammu, before reaching Delhi to celebrate National Milk Day. Secretary, DAHD Flag Off the rally at Dhaula Kuan, New Delhi and Hon'ble Minister of State, Prof. S.P. Singh Baghel received the Amul Clean Fuel Rally at Manekshaw Centre, New Delhi that included over 77 participants from various Member Unions of Amul and over 25 branch offices of GCMMF across India, who travelled all the way to Delhi to celebrate **National Milk Day**. The rally showcased the dynamic spirit of India's dairy sector and celebrated its achievements, emphasizing the vital role of farmers and veterinary support systems.

During the celebrations, following significant publications were launched by the Hon'ble Union Minister for Fisheries, Animal Husbandry & Dairying:

- **Manual for Surabhi Chayan Shrankhala (HGM Livestock Selection Programme):** This manual provides a comprehensive guide for the identification and selection of elite livestock, facilitating the development of a superior milch herd and supporting sustainable livestock management.
- **Standard Operating Procedures for Artificial Insemination Technicians:** This document outlines best practices and protocols to enhance the efficiency and success rates of artificial insemination services, thereby contributing to genetic improvement in livestock.
- **Basic Animal Husbandry Statistics Book -2024:** information on the Major Livestock products (MLPs) data like: Annual Production Growth Rate, per Capita Availability, Average yield per Animal, State-wise & Species-wise share etc.

- II. During the month the DAHD has organized goat conclave in Mathura on 18.11.2024 for the first time in collaboration with the Central Institute for Research on Goat

(CIRG). The programme was attended by 3000 farmers, students, pashu sakhis, along with other category of the participants. Followed by a stakeholder's consultation cum seminar was held in Agra on 19.11.2024 under the chairmanship of Secretary wherein a brainstorming discussion was held on the prospect, challenges and way forward on the goat farming which will help nearly 26 cr. poor farmers in developing new models of entrepreneurship.

- III. Two EFCs were held, chaired by Secretary, D/o Expenditure, on Rashtriya Gokul Mission & National Programme for Dairy Development. Cabinet Notes would be circulated in this Month.

#### IV. Vaccination programme – salient achievements

##### i. FMD Vaccination

Round 4 so far 23.61 crore FMD vaccination done and completed in 25 States/UTs and ongoing in 11 States/UTs.

Round 5 so far 8.98 crore FMD vaccination done and completed in 6 States/UTs and ongoing in 10 States/UTs.

Round 6 of FMD vaccination started in Karnataka and so far, 1.47 crore (including Haryana) vaccination has been done.

Overall, during the month of November 2024, around 6.01 Crore-FMD Vaccination has been done

##### ii. Brucellosis Vaccination

During the month 12 lakh Brucellosis vaccinations has been done (Cumulative 4.36 crore)

##### iii. Peste des Petits Ruminants (PPR) Vaccination

During the month 1.17 Crore PPR vaccinations has been done. (Cumulative 18.61 crore)

##### iv. CSF (Classical Swine Fever) Vaccination

During the month, total 1.36 lakh CSF vaccinations has been done. (Cumulative 61.27 lakh)

v. **Vaccination against Lumpy Skin Disease (LSD)**

During 2024, there are very few incidents of LSD. Presently, Two States (Madhya Pradesh -2 cases, Kerala – 21 cases) are having active cases of Lumpy Skin Disease. Total 7,98,58,586 animals have been vaccinated during 2024 and the vaccination is underway.

**V. MOBILE VETERINARY UNIT (MVU)**

Overall, 4016 MVUs are operational in 28 states as on 30<sup>th</sup> November providing last mile doorstep animal health care services. During the month, 3,67,101 farmers were benefitted and 6,71,438 number of animals were treated in 9 states.

**VI. Activities/ Works related to Chaudhary Charan Singh National Institute of Animal Health (CCSNIAH):**

Completed quality control testing of 03 batches of PPR vaccines under LHDCP.

**VII. Expenditure\_**

Overall Rs. 126.05 cr. Expenditure was incurred in the Month of November, 2024. Overall expenditure incurred was Rs. 1877.90 cr. (46.78% of RE) as compared to Rs. 891.90 cr. (21.32% of RE) as in Financial Year 2023-24.
