- 2. **Description of Job**: Outsourcing the services of a FSSAI Consultant/ Profession al through the Consultancy Firm having expertise in providing services to Govt./ Semi Govt./Organized Dairy Firms/ Private Limited Organization dealing with iss ues related to law as well as food w.r.t. FSSAI regulatory compliance and manda

tory terms & conditions etc. as per the specified Terms of Reference (TOR).

- 3. **Terms of Reference (TOR)**: Delhi Milk Scheme is a central government organ ization under Department of Animal Husbandry and Dairying, Ministry of Fisheri es, Animal Husbandry and Dairying, which is situated at Shadipur, West Patel N agar, New Delhi-110008. DMS is engaged in processing and marketing of milk a nd milk products in NCT of Delhi. DMS intends to outsource the services of Cons ultancy Firm having expertise in providing services to Govt./ Semi Govt./ Organi zed Dairy Firms/ Private Limited Organization dealing with issues related to law as well as food w.r.t. FSSAI regulatory compliance and mandatory terms & conditions etc. The firm has to carry out the complete work of FSSAI and related activities as under. DMS is getting its milk and milk products packed from Milk Union s of Haryana Dairy Development cooperation Federation (HDDCFL) under 3rd party agreement under Relabeller license from FSSAI.
 - A. **Consultancy:** Updating of Quality Manuals (Existing SOP's and manuals will be provided), Management System Preparation of Procedures (MSP) i ncluding Food Safety Management Systems (FSMS), Formats and SOPs. The Consultant shall act as facilitator and handhold DMS in development and approval of documentation as per FSSAI format and requirements. The consultancy firm must process appropriate knowledge of Quality by Design concept including Pasteurization, Processing of Milk & Milk products, including knowledge of Aseptic lines along with cleaning and sanitation process.
 - B. In the event of operationalisation of DMS's new/ renovated production u nit, technical consultancy support w.r.t Quality by design, quality assuran ce and quality control to protect the interest of DMS w.r.t. FSSAI regulato ry compliance and mandatory terms & conditions etc.
 - C. **Quality Auditing (Quality, Food safety and HACCP):** Pertinent to D MS's present 3rd party MoU for processing & packing arrangement with H aryana Dairy Federation and its affiliated Milk Unions to protect the inter est of DMS w.r.t. FSSAI regulatory compliance and mandatory terms & conditions etc.
 - D. To assist and support in terms of quality aspects for handling issues of

media, publicity awareness campaign, advertisement etc to protect the i nterest of DMS w.r.t. FSSAI regulatory compliance and mandatory terms & conditions etc.

- E. To extend technical support in terms of quality by design, quality assurance an d quality control and liaison with Central and State governments w.r.t. FSSAI reg ulatory compliance and mandatory terms & conditions etc.
- F. The consultancy firm will provide technical assistance and support to operation personnel of DMS w.r.t. FSSAI regulatory compliance and mandatory terms & conditions etc.
- G. To extent support and assistance in terms of techno-legal aspects to DMS in FS SAI related court cases, FSSAI regulatory compliance etc and requirements of a bove-mentioned terms and conditions.
- H. To support and assist in terms of quality checks/verification/validation, if required at marketing sites of DMS to ensure the quality and food safety of products. Verification/validation report should be shared with DMS management within 48 to 72 hours from the date of verification/validation.
- I. The consultancy firm shall be facilitating training and development of the techn ical staff/employees w.r.t. Key processes of Milk & Milk products including FSSAI Schedule IV requirements, FOSCOS compliances. The objective of the above program is to ensure self-development and take ownership in processes to minimiz e product non-compliances w.r.t. FSSAI.
- 4. Details of some of the major tasks of the FSSAI Consultant/ Profession al engaged through the Consultancy Firm as described in TOR at Para 2 above:
- A. Plant visit to ensure that the facility and product shall meet the local regulatory requirement (FSSAI/Legal Metrology etc.) w.r.t. FSSAI regulatory compliance an

d mandatory terms & conditions etc. Plant visit report should be shared with DM S management within 48 to 72 hours from the date of plant visit.

- B. Verification of QA/QC documents for Delhi Milk Scheme branded products w.r.t. FSSAI regulatory compliance and mandatory terms & conditions etc. The firm should be in a position to guide DMS team technically.

- 6. Support in the label related queries from FSSAI/Customer until any new modific ation in the regulation w.r.t. FSSAI regulatory compliance and mandatory terms & conditions etc.
- 7. To extend support and technical assistance to address and resolve any label-re lated queries from regulatory authorities or customers, keeping abreast of any r egulatory changes w.r.t. FSSAI regulatory compliance and mandatory terms & c onditions etc.
- 8. To assist in obtaining necessary clearances and approvals for products obtaine d from third parties/ other State Dairy Federations (from States other than Delhi and Haryana) to enter the market of NCT of Delhi and Delhi NCR w.r.t. - 1. The Consultancy Firm must possess at least one year experience in dealing wit h issues related to law as well as food w.r.t. FSSAI regulatory compliance and m andatory terms & conditions etc. The firm should have experience and exposur e in both Professional Dairy and Food industry including multinational food and dairy companies.
- 2. The consultancy firm should have expertise and experienced manpower having minimum 01 year experience and minimum qualification as IDD/B.Sc. /B-Tech (Dairy/ Food)/ M-Tech (Dairy/ Food)/ B.Sc. (Dairy/ Food)/ M. Tech in Food safety a nd management in dealing with food/dairy industry having exposure in handling FSSAI related cases w.r.t. FSSAI regulatory compliance and mandatory terms & conditions etc. Experience certificate issued by authorities of any such food/dair y company to be furnished.
- 3. The consultancy firm should possess technical know-how of both Indian and int ernational food laws and regulatory requirements.
- 4. The Consultancy Firm should have support team with technically qualified pers ons having qualification and experienced mentioned in point No. 2 above. Documents with self certification to be furnished.
- 5. The consultancy Firm should also possess very strong liaison credentials with F SSAI/FDA officials and should be capable of delivering results when required to s afe guard company's reputation. The success rate for complying FSSAI lifted sa mples should be 90% plus. The firm should also be in a position to coordinate a ppropriate authority and delay the date of implementation for draft FSSAI notifications, where organizations may suffer in terms of financial losses/reputation losses/other damage to the brand.
- 6. The consultancy firm should be a in a position to technically help the organizati on in projects (Greenfield/Brownfield projects) to ensure the concept of Quality by design, aspects of quality, food safety to ensure product comes out of the lin e is FIRST TIME RIGHT.

Special Terms and Conditions of the Service are as under: -

1. Eligibility Criteria required for Consultancy Firm:

- (i) The Consultancy Firm must possess at least one-year experience in providing services of Professionals/ consultants to Govt./Semi Govt./Organized Dairy Firms/Private Limited Organization/Multinational food companies dealing with issues related to law as well as food w.r.t. FSSAI regulatory compliance and mandatory terms & conditions etc.
- (ii) The Consultancy Firm must have its Firm Registration Certificate and GST Certification.
- (iii) The Firm has to provide the documentary evidence of its eligibility criteria including financial turnover in their technical bid for their eligibility to qualify for opening of financial bid.
- (iv) The selected/shortlisted L-1 consultancy firm (after opening of financial bi d) shall provide the qualification and experience certificates of the profession al/ consultant required to be engaged before Award of Contract/ Tender throu gh email to procuring entity (Delhi Milk Scheme) for scrutiny. - 4. EMD, Financial Turnover: EMD & Financial Turn Over are exempted for MSE / St artup firms. - 6. **Security Deposit:** Successful Bidder is required to deposit 10% security amou nt of total annual value of the contract for due performance in the shape Dema nd Draft / Pay order / Fixed Deposit Receipt (FDR) in favour of General Manager, Delhi Milk Scheme which shall be refunded after completion of the contract peri od. No interest on security deposit shall be paid.
- 7. **Period of Contract:** The initial contract will be for the period of Two years whi ch can be further extended for another one year depending upon the satisfactor y performance and at the sole discretion of General Manager, DMS or till the ha nding over the Operation & Management of DMS or closure of DMS activity which hever is earlier.
- 8. Charges for consultancy services (Salary/Wages): DMS shall pay the amo unt of Rs.70000 + Services Charges + GST per month to the contractor and the contractor shall pay the lump-sum amount of Rs.70,000 per month to his deployed manpower through Bank Account by 7th of every month. - K. Check product formulations and specifications to ensure they meet regulatory r equirements, including Certificate of Analysis (CoA) compliance.
- L. Create a Dossier for each product for the records and references.

- 5. Maintain organized documentation for each product, including formulation deta ils, regulatory approvals, and compliance records w.r.t. FSSAI regulatory compli ance and mandatory terms & conditions etc.
- 6. Support in the label related queries from FSSAI/Customer until any new modific ation in the regulation w.r.t. FSSAI regulatory compliance and mandatory terms & conditions etc.
- 7. To extend support and technical assistance to address and resolve any label-re lated queries from regulatory authorities or customers, keeping abreast of any r egulatory changes w.r.t. FSSAI regulatory compliance and mandatory terms & c onditions etc.
- 8. To assist in obtaining necessary clearances and approvals for products obtaine d from third parties/ other State Dairy Federations (from States other than Delhi and Haryana) to enter the market of NCT of Delhi and Delhi NCR w.r.t. FSSAI reg ulatory compliance and mandatory terms & conditions etc.
- 9. To support in terms of techno-legal obligation raised by authority in the court of law of India, including after change in regulatory provisions. Provide techno-legal support ensuring compliance with current regulations w.r.t. FSSAI regulatory compliance and mandatory terms & conditions etc.
- 10. Any other work pertaining to the requirement of regulatory food safety require ments w.r.t. FSSAI regulatory compliance and mandatory terms & conditions et c.

The Consultancy Firm must possess at least one year experience in dealing wit

e in both Professional Dairy and Food industry including multinational food and
dairy companies.

- 2. The consultancy firm should have expertise and experienced manpower having minimum 01 year experience and minimum qualification as IDD/B.Sc. /B-Tech (Dairy/ Food)/ M-Tech (Dairy/ Food)/ B.Sc. (Dairy/ Food)/ M. Tech in Food safety a nd management in dealing with food/dairy industry having exposure in handling FSSAI related cases w.r.t. FSSAI regulatory compliance and mandatory terms & conditions etc. Experience certificate issued by authorities of any such food/dair y company to be furnished.
- 3. The consultancy firm should possess technical know-how of both Indian and int ernational food laws and regulatory requirements.
- 4. The Consultancy Firm should have support team with technically qualified pers ons having qualification and experienced mentioned in point No. 2 above. Documents with self certification to be furnished.
- 5. The consultancy Firm should also possess very strong liaison credentials with F SSAI/FDA officials and should be capable of delivering results when required to s afe guard company's reputation. The success rate for complying FSSAI lifted sa mples should be 90% plus. The firm should also be in a position to coordinate a ppropriate authority and delay the date of implementation for draft FSSAI notifications, where organizations may suffer in terms of financial losses/reputation losses/other damage to the brand.
- 6. The consultancy firm should be a in a position to technically help the organizati on in projects (Greenfield/Brownfield projects) to ensure the concept of Quality by design, aspects of quality, food safety to ensure product comes out of the lin e is FIRST TIME RIGHT.

Special Terms and Conditions of the Service are as under: -

1. Eligibility Criteria required for Consultancy Firm:

(i) The Consultancy Firm must possess at least one-year experience in providing services of Professionals/ consultants to Govt./Semi Govt./Organized Dairy Firms/Private Limited Organization/Multinational food companies dealing with issues related to law as well as food w.r.t. - (ii) The Consultancy Firm must have its Firm Registration Certificate and GST Certification.
- (iii) The Firm has to provide the documentary evidence of its eligibility criteria including financial turnover in their technical bid for their eligibility to qualify for opening of financial bid.
- (iv) The selected/shortlisted L-1 consultancy firm (after opening of financial bi d) shall provide the qualification and experience certificates of the profession al/ consultant required to be engaged before Award of Contract/ Tender throu gh email to procuring entity (Delhi Milk Scheme) for scrutiny. The procuring entity reserves its right to call the professional/ consultant (proposed to be engaged by consultancy firm) for an interview to determine his ability to complet e the required job. The consultancy firm shall be bound to provide another suitable professional/ consultant in the above case within a period of 15 days, failing which Award of Contract may be cancelled and tender may be scrapped. Decision of GM, DMS shall be final and binding to both the parties in this matter.
- (v) During the currency of contract period, if the engaged professional/ consultant leaves the job from the parent/ selected consultancy firm, it shall be responsibility of the consultancy firm to provide the suitable professional/ consultant as per the qualification & experience mentioned in the RFP and aft er meeting the satisfaction of procuring entity within 15 days, failing which contract may be terminated by forfeiture of Security Deposit by GM, DMS.

- 3. **Financial Turnover**: As per guidelines of GeM.
- 4. EMD, Financial Turnover: EMD & Financial Turn Over are exempted for MSE / St artup firms. Other bidders are required to deposit 2% EMD of estimated Annual value of the contract in the shape Demand Draft / Pay order in favour of Genera I Manager, Delhi Milk Scheme. The EMD in original may be submitted in Delhi Milk Scheme before the 'Bid End Date' failing which their tender will not be considered. Further, copy of the EMD may be uploaded along with the tender on GeM Portal. The Consultancy Firm shall be engaged by DMS on Hybrid Mode (online/off Line).

- 14. Statutory Requirement: The contractor is required to abide by all statutory r

equirements as per Law applicable during the contract period.

- 15. In case contractor fails to perform the job at any time or mandatory records ar e not maintained or minimum salary/wages are not paid to worker or any terms & conditions of contract are not complied, the General Manager, Delhi Milk Sche me will treat such act as breach of contract and shall be free to cancel the contract and make alternative arrangements to get the job done. Security deposit can be forfeited and penalty can be recovered from any payable bills of existing contracts or any other contracts of the firm apart from taking other legal/administrative action.
- 16. **Modification:** In case of any hardship/operational problems faced by either party (i.e. contractor or DMS). General Manager, DMS have the right to add/modify any conditions in the public interest by recording reasons to this effect.
- 17. **Short Close of Contract:** The said contract can be short closed/cancelled at any time without assigning any reason at the sole discretion of General Manger, Delhi Milk Scheme, if any terms & condition is violated or performance of the contractor/deployed manpower is not satisfactory. Further, above contractor can be short closed with one month notice if O&M of DMS is handed over to external agency or Closure of DMS activities or functional requirement of deployed manp ower ceased to exist.
- 18. **Jurisdiction:** all dispute arising out of or touching on the contract shall be subjected to the jurisdiction of the court of Union Territory of Delhi Only.

Any other document in support of contract execution like Third Party Inspection release note, etc.Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a.
