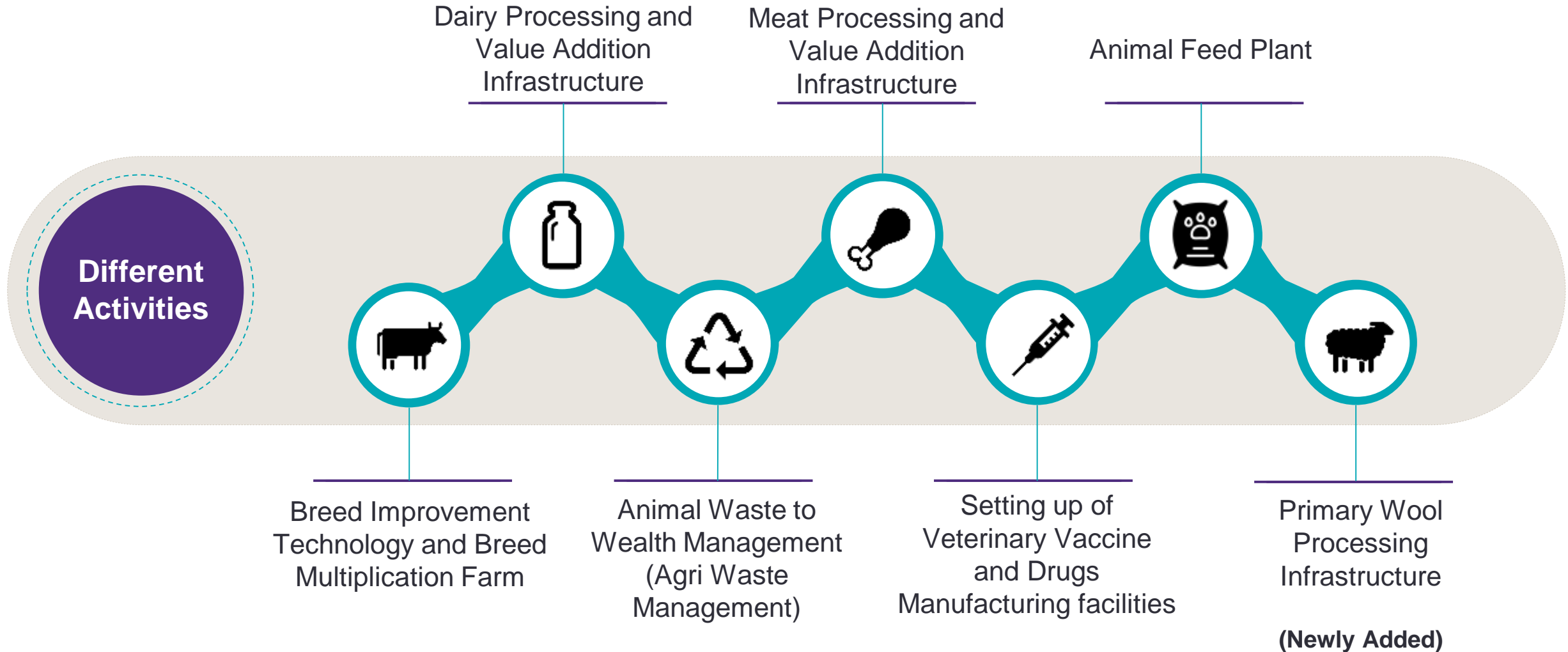

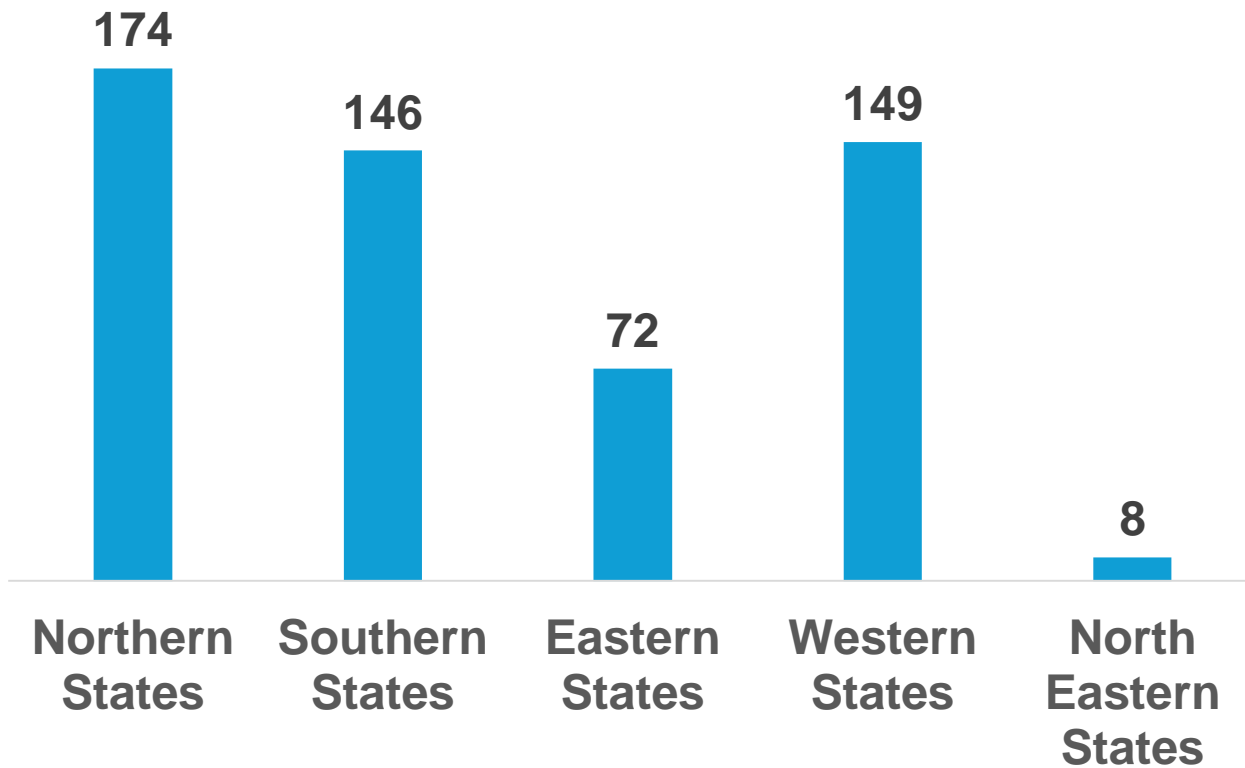

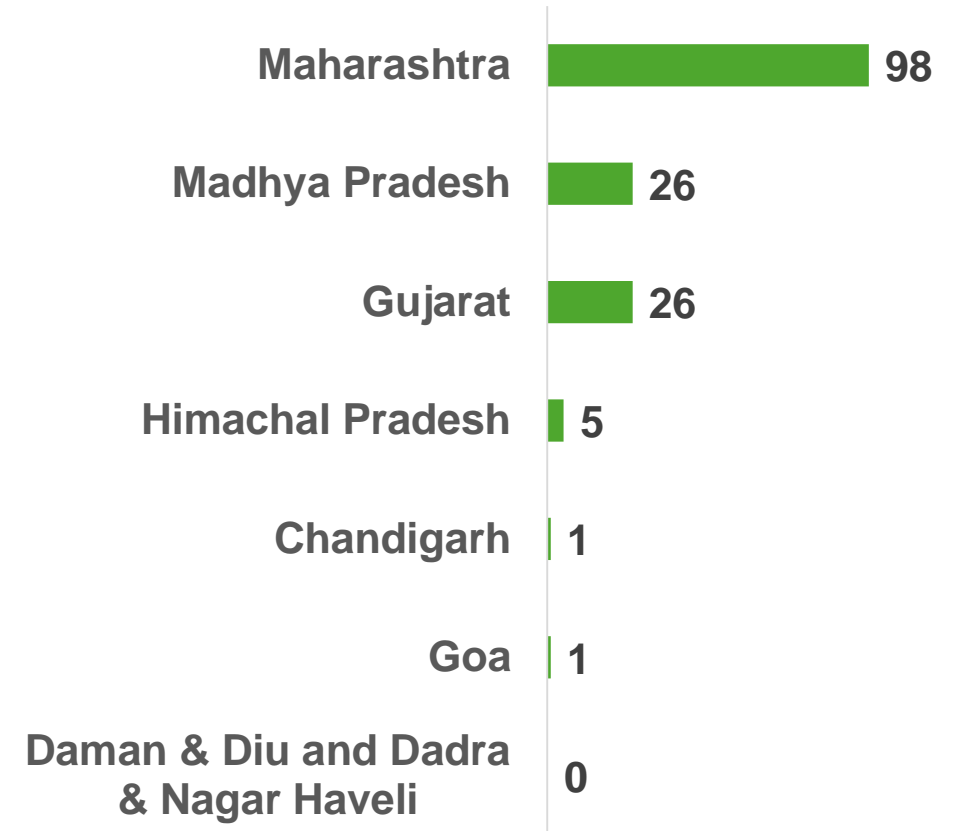

Region Wise Sanctioned Projects

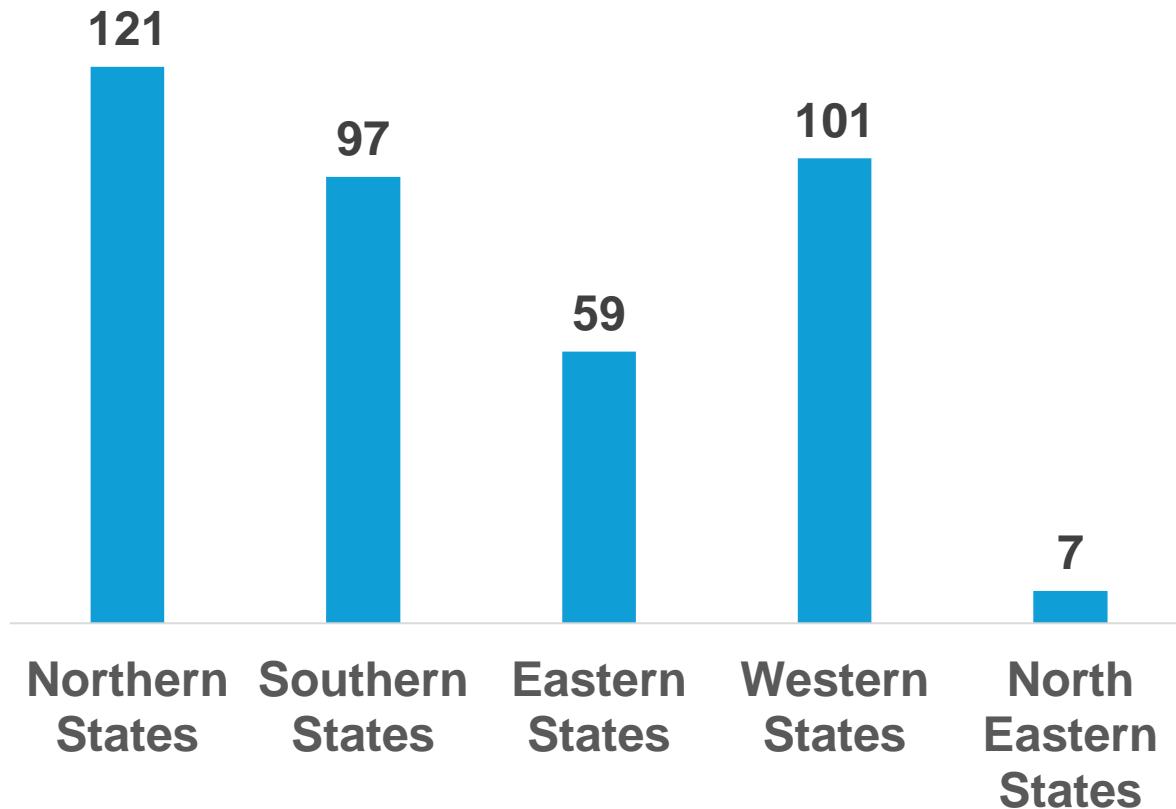


State Wise Sanctioned Projects

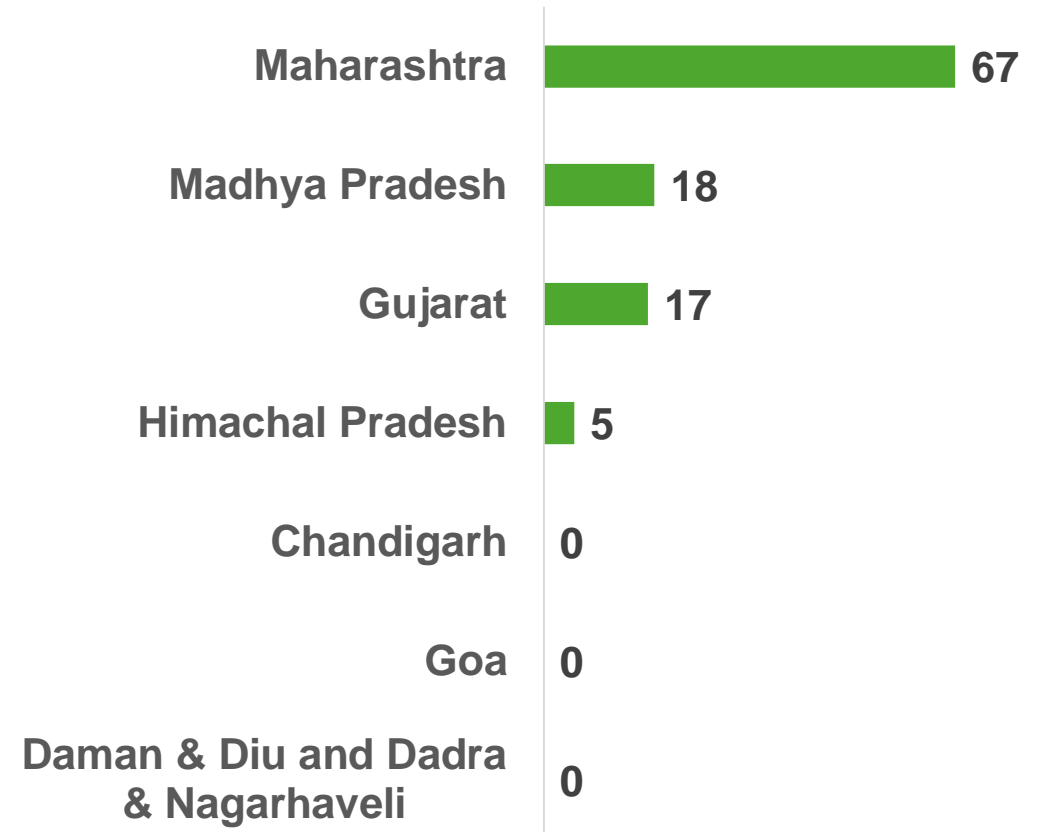


Performance Comparison (Approved Projects)

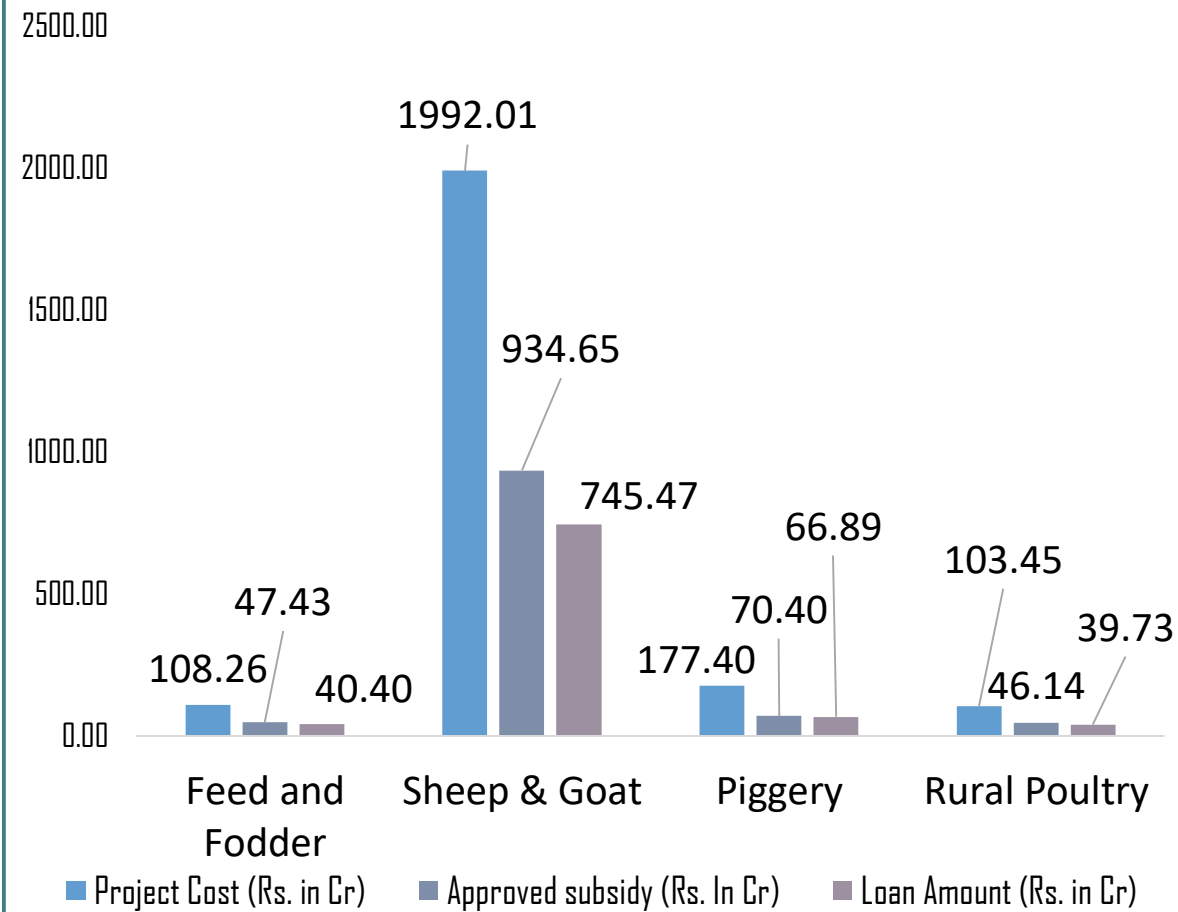

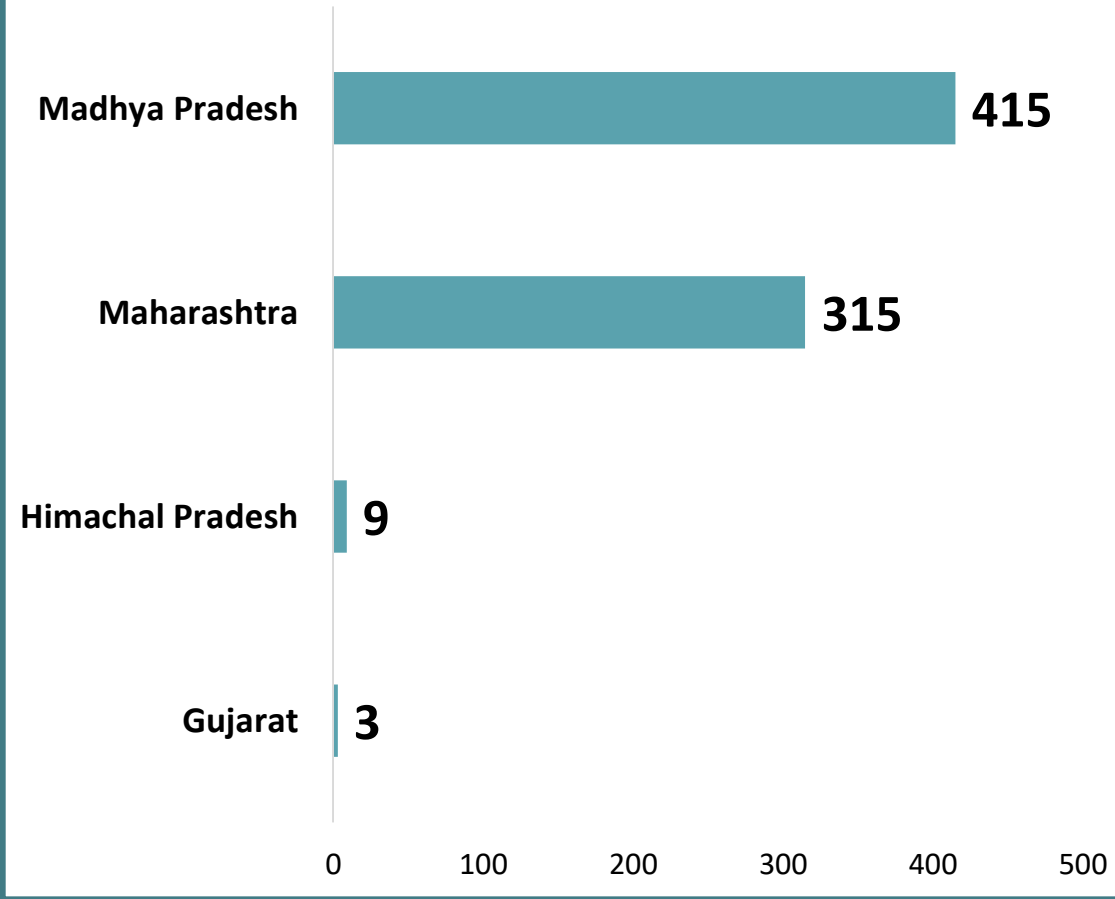
State wise Performance Comparison

Region Wise Approved Projects



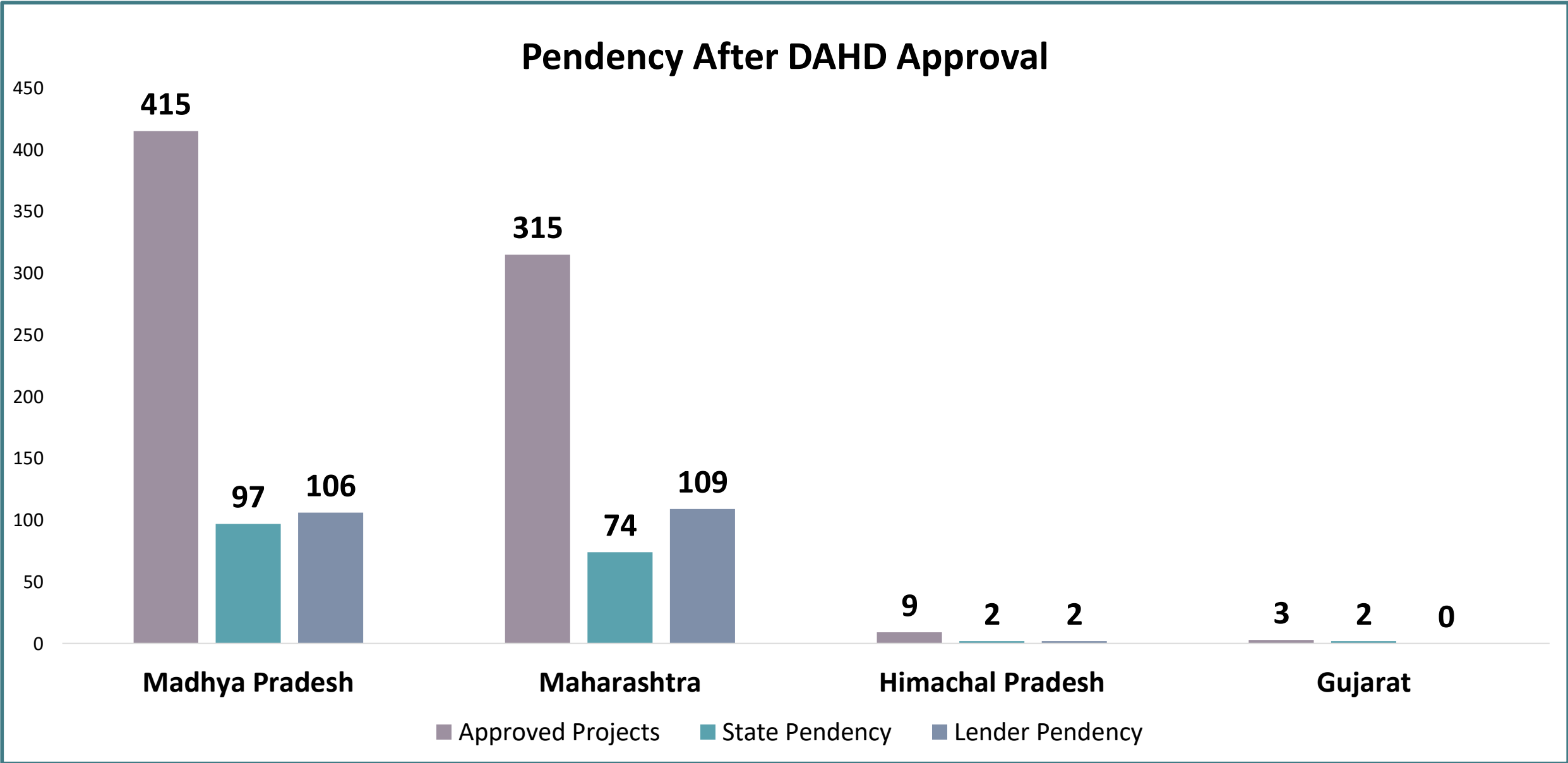

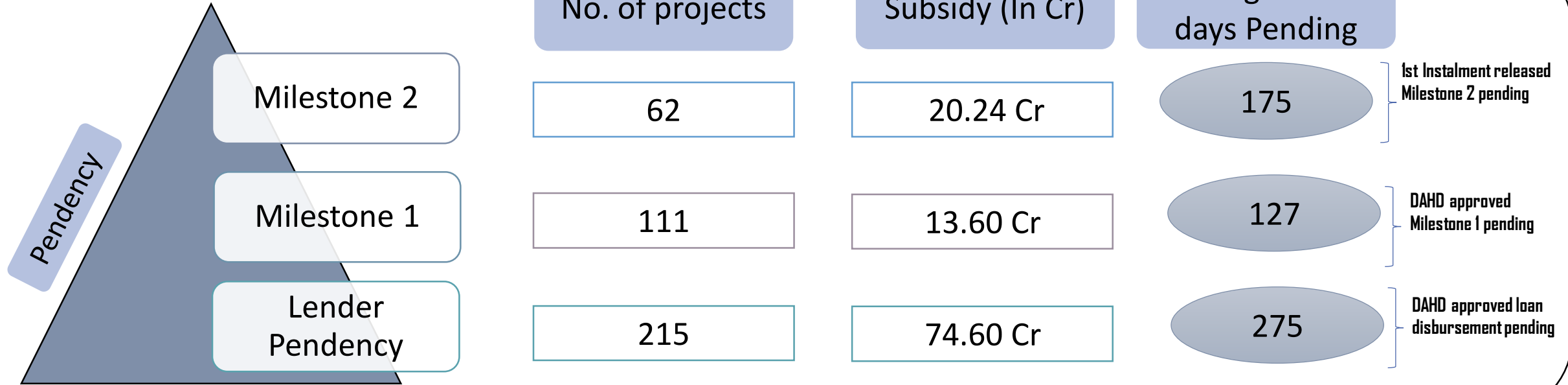

It is observed that none of the District SPCAs are effectively functioning.

The States are requested to carryout the following initiatives:

1. The State Animal Welfare Board (SAWB) to be reconstituted by the States and make them functional in compliance with Hon'ble Supreme Court order.
2. The District SPCAs should be established and made functioning to prevent unnecessary or suffering to animals and to submit annual activities reports to the Board.
3. Implement the Dog Breeding and Pet Shop Rules and register the dog breeding establishments, pet shops and to submit annual report to AWBI.
4. The provisions of the Animal Birth Control Rules, 2023 to be effectively implemented and State Department of Animal Husbandry shall proactively participate in the programme.
5. The proper implementation of the Transport of Animals Rules, 1978(as amended in 2001 and 2009) which will not only reduce the pain or suffering to animals during transportation but also prevent spreading of diseases.
6. The proper implementation of Prevention of Cruelty to Animals (Application of Fines) Rules, 1978 will enable to strengthen the functioning of District SPCAs and financially.
7. Organize regular awareness programmes for schools & college students, veterinarians, farmers, Police and Judiciaries on animal welfare for which AWBI has prepared module.
