- 7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and

2. Scope of Work:-

- a) The tenderers/bidders have to carry out D.G.A (Dissolved Gas Analysis) of all oil cooled transformers from NABL Acced Laboratory. Apart from this, other routine jobs such as Relay Calibration, Dehydration and filtration of Transform HT OCBs replacement of silica gel, Temperature gauge, cleaning of LT/HT bas bar, cleaning of dry type transformer h resistance test, Maggering of LT/HT cables and HT transformers etc are also to be carried out by the party in tim heir own cost for which no payment shall be made extra. In case the above jobs are not carried out in time, no pay of AMC charges shall be made to the party till the time the above jobs are completed and duly certified by user se Dairy Engineer.

- e) All the spare parts, consumables, calibration and other all material required for maintenance of above equipments shall be arranged/ provided by the contractor at his own cost and DMS shall not pay anything extra in this regard.

Payment Terms: Payment Terms: The payment will be made on monthly basis on submission of bills on Ge ortal for the job duly verified by Dairy Engineer which will be forwarded by them to Account Officer (Store Paym t) for payment through PFMS through GeM Portal. The contractor will also furnish a certificate on each bill that ayment to workers has been made as per terms and condition of Tender. Further, ESI & EPF contribution has bee made and GST payment has been made to concerned authority" (proof to be enclosed). The contractor is requir to pay the wages /salary to their workers through their Bank Account. The contractor has to attach a list of wor s, proof of payment made through Bank Account & contribution of ESI & EPF, payment of GST to concerned auth ties along with the bill duly certified by DE/ SDE. DMS shall pay one day extra wages/payment for each Republ ay holiday (26th January), Independence day Holiday (15th August) and Gandhi Jayanti (2nd October) to contrar for paying the same to all deployed workers who perform the duty on these Gazetted holidays.

In case contractor fails to make payment of the minimum wages including overtime wages within the prescribe eriod i.e. within a month or make short payment to the worker/workers engaged by it, General Manager, DMS rerves the right to make such payment(s) from contractor's current bill(s) or any other pending bill(s) by lawful n ns. If the amount required for payment falls short, it shall be appropriated recovered from the security deposit he contractor apart from taking any other action as per rule.
- **26. No claim for regular job:** The labours/workers engaged by contractor under this contract shall not have any m or right for their engagement in Delhi Milk Scheme on regular basis or otherwise.
- **27. Compensation:** In the event of an accident or mishap resulting in any disability, injury or death of employee aged by party during the period of the contract the compensation, damage etc. are to be paid by contractor. DI shall not be liable in any manner either monetarily or otherwise.
- **28. Safety Guideline:** Tenderer should ensure that the staff deployed by him follow all statutory and safety guideling while working on electrical equipment. In this connection DMS in no way will be responsible for any untoward ppenings during the contract period.
- **29. Statutory Requirement:** The contractor is required to abide by all statutory requirements as per Law applical during the contract period.
- **30. Modification :** In case of any hardship/operational problems faced by either party (i.e. contractor or DMS). Ge al Manager, DMS have the right to add/modify any conditions in the public interest by recording reasons to this ect.
- **31. Short Close of Contract:**(i) On breach of any terms and conditions, the said contract can be short closed/can ed at any time without assigning any reason at the sole discretion of General Manger, Delhi Milk Scheme. (iv) In case of shifting of entire DMS operation to any other Milk Union/Dairy Federat etc and/or short closing/termination MoU between DMS and Haryana Dairy Federation, the above contract can be hort closed by giving one months notice. (v) The contract can also be short closed under any unforeseen circur ances beyond the control of DMS by providing one months notice.
