- 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

- 1. **Goods & Service Taxes:** Goods & Service Tax shall be paid by DMS on production of documentary evidence.
- 2. **Period of Contract:-**The above job is to be completed within 30 days from the date of issue of job order, failing which the LD charges as per rules shall be recovered.
- 3. Earnest Money Deposit (EMD): As per GeM Guidelines.
- **4. Security Deposit:** You are required to deposit 5% security amount of the total value of the contract in the shape of Demand Draft/Pay order/FDR in favour of General nager, Delhi Milk Scheme within 10 days from the issue of the job order failing which he same shall be deducted from the payable bills. The security amount shall be refued after completion after guarantee period of six months.
- 5. **Site Visit:** Before quoting the rates, the contractor may visit Delhi Milk Scheme to cess quantum of work and the requirement of items for carrying out the job in time. y clarification required may be got from Engineering Section of DMS on any working ays between 10 am to 4 pm. No request will be considered after opening of e-Tende
- 6. **Payment Terms:** The payment shall be made after completion of the Job and on semission of bills on GeM Portal for the job duly verified by Dairy Engineer/Designated ficer which will be forwarded by them to Account Officer (Store Payment) for payment through PFMS through GeM Portal.
- 7. **Guarantee Period:-** The party is required to stand the Guarantee Period of six nths.
- 8. **Statutory and Mandatory Provision:** The contractor shall abide by all the statut y and mandatory provisions of labour/Industrial laws in force from time to time. In eany challan/ fine is levied under Statutory Act, DMS will not be responsible for any olation of law by Party and the contractor will be fully responsible for its settlement d of any statutory and the mandatory requirements such as Medical, Insurance etc.
- 9. **Compensation:** In the event of an accident or mishap resulting in any disability, ir y or death of employee engaged by party during the period of the contract the com

nsation, damage etc. are to be pa by contractor. DMS shall not be liable in any manner either monetarily or otherwise.

- 10. **Safety Guidelines :** Tenderer should ensure that the staff deployed by him followall statutory and safety guidelines while working. In this connection DMS in no way be responsible for any untoward happenings during the contract period.
- 11. **Statutory Requirement**: The contractor is required to abide by all statutory re rements as per Law applicable during the contract period.
- 12. **Modification:** In case of any hardship/operational problems faced by either part .e. contractor or DMS). General Manager, DMS have the right to add/modify a conditions in the public interest by recording reasons to this effect.
- 13. **Jurisdiction:** All disputes arising out of or touching on the contract shall be subject to the jurisdiction of the court of Union Territory of Delhi only.
- 14. **Short Close of Contract:** (i) On breach of any terms and conditions, the said co act can be short closed/cancelled at any time without assigning any reason at the said discretion of General Manger, Delhi Milk Scheme. (ii) The contract can be short clos at any time if O & M of DMS is given to external agency or DMS activity is closed due of any reasons, whichever is earliest. (iii) In case of closure of DMS activities, contract may be short closed without any notice. (iv) In case of shifting of entire DMS operation any other Milk Union/Dairy Federation etc and/or short closing/termination MoU I ween DMS and Haryana Dairy Federation, the above contract can be short closed. (The contract can also be short closed under any unforeseen circumstances beyond control of DMS.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
