MINUTES OF THE 19th NATIONAL STEERING COMMITTEE (NSC) MEETING HELD ON 24.06.2025

The 19th NSC meeting of RGM was held under the Chairpersonship of Secretary (AHD) on 24.6.2025 at 11:30 AM in Krishi Bhawan. The list of participants is at **Annexure-I**.

At the outset, the Chairman welcomed all the participants, and it was followed by agenda wise presentation by the Cattle Division to deliberate on the various project proposals for consideration by the National Steering Committee.

Agenda 1: Proposal for establishment of Heifer rearing centres (HRCs)

1.1 Department has received 3 proposals (from Dudhsagar Dairy Mehsana, Banas Milk union Palanpur & Sumul Dairy – Surat) under the component of Establishment of Heifer rearing centres. The proposal was appraised by division as per the guidelines of the Scheme.

1.2 After a detailed discussion, it was decided to approve all the 3 projects received under the component of the establishment of HRCs as per the details at **Annexure II**.

Agenda 2: Implementation of Nationwide Artificial insemination programme (2025-26)

2.1. Department has submitted the detailed proposal for Nationwide Artificial Insemination Programme for year 2025-26 with an outlay of Rs. 262.33 crores. During the discussion, it was mentioned that recoding data on PD and calving on Bharat Pashudhan Portal is lagged in most of the State under the programme. Therefore, State may upload data for the AI performed upto February 2025 on an immediate basis. Release of funds may be considered under the component after uploading of aforementioned data by the States on the portal.

2.2 After discussion, programme division was directed to resubmit revised proposal in the next NSC.

Agenda 3: Establishment of Community resource persons/ MAITRIs under RGM

3.1. Department has submitted the detailed proposal for establishment of Community resource persons/ MAITRIs under RGM with an outlay of Rs. 10662.03 lakhs.

3.2 After a detailed discussion, the proposal was approved with an allocation of Rs. 10662.03 lakh for establishment of 13163 Community resource persons/ MAITRIs under RGM as per details at **Annexure III**.

Agenda 4: Revival of already approved projects by NSC

4.1. Proposal from ICAR institutes regarding strengthening of semen stations, and other projects that were previously approved by the National Steering Committee (NSC) for revival under the revised Rashtriya Gokul Mission (RGM). These projects had been put on hold due to a paucity of funds during the financial year 2024–25, prior to the approval of the Cabinet Note for the revised RGM. With sufficient funds now available under the scheme, the Department proposes to revive and implement the projects already approved by the NSC.

4.2. After discussion, programme division was directed to resubmit proposal with detailed justification during the next NSC meeting.

Other decisions taken during the meeting:

1. Division was directed to prepare detailed gap analysis for establishment of MAITRIs in the country.
2. All Government & private IVF lab physical progress should be updated on Bharat Pashudhan
3. Allocate the 30 Heifer Rearing Centre (HRC) projects in an equitable manner across the States, ensuring balanced regional development and effective implementation of the programme.
4. All States were directed to identify and enlist private semen stations operating within their jurisdiction within a period of one month. States are further advised to bring these private semen stations under their regulatory and administrative purview to ensure uniform standards of semen quality. Further, all States were directed to finalize and notify their respective State Breeding Policies and enact the State Breeding Acts within the current financial year. These measures are essential to establish a comprehensive legal and policy framework for regulating breeding activities, ensuring genetic improvement, and maintaining breed purity.
5. Detailed information regarding the fund requirements for the current financial year under the scheme, along with an assessment of committed liabilities for the next financial year.
6. All States and Union Territories were directed to upload data related to Artificial Insemination (AI), Pregnancy Diagnosis (PD), and calves born up to February 2025 by the end of the current month on NDLM for further release of funds under NAIP.

The Meeting ended with a vote of thanks to the Chair.
