MINUTES OF THE 22ND NATIONAL STEERING COMMITTEE (NSC) MEETING HELD ON 27.11.2025

The 22nd NSC meeting of RGM was held under the Chairpersonship of Secretary (AHD) on 27.11.2025 in Krishi Bhawan New Delhi. The list of participants is at **Annexure-I**.

At the outset, the Chairman welcomed all the participants, and it was followed by agenda wise presentation by the Cattle Division to deliberate on the various project proposals for consideration by the National Steering Committee.

Agenda 1: Proposal for establishment of Heifer rearing centres (HRCs)

1.1 Department has received 8 proposals under the component of Establishment of Heifer rearing centres. The proposals were appraised by division as per the guidelines of the Scheme.

- a) Baani Milk Producer Organization, (Punjab)
- b) Harit Pradesh Milk Producer Organization, (Uttar Pradesh)
- c) Maahi Milk Producer Organization, (Gujarat)
- d) Paayas Milk Producer Organization, (Rajasthan)
- e) Saahaj Milk Producer Organization, (Uttar Pradesh)
- f) Kolhapur District Co-Operative Milk Producers Union Ltd., Kolhapur, (Maharashtra)
- g) Nagaland Livestock Development Board, (Jalukie)
- h) Bihar Livestock Development Agency (Munger)

1.2 After a detailed discussion, it was decided to approve all the 8 projects received under the component of the establishment of HRCs as per the details at **Annexure II**. It was further mentioned that the release of funds under this component shall be conditional upon each Implementing Agency submitting an undertaking that:

- (i) The HRC will be technically supported and guided by the State Livestock Development Board or NDDB for formulation of norms and practices to ensure the viability and profitability of the project;
- (ii) The IVF laboratory or service provider proposed to undertake IVF activities in the HRC has been duly identified and indicated; and
- (iii) The Implementing Agency has adequate financial resources to meet the remaining working capital and recurring costs of the project, other than the Government subsidy.

Agenda 2: Establishment of Breed Multiplication Farms

2.1 A detailed status of the BMF projects was presented during the meeting by the Division. It was mentioned that out of the 169 originally sanctioned projects, 48 projects have been cancelled and at present 121 projects (111 large farms & 10 small farms) are active projects under the scheme.

2.2 NDDDB has waitlisted BMF projects under the component of establishment of BMF along with net worth and loan sanctioning letters issued by banks/ financial institutions. Received proposals were arranged as per the date of receipt of proposal from NDDDB and followed by date of loan sanction by Bank/ financial institution as per procedure adopted by DAHD.

2.3 As per CCEA approval Department has to sanction a total of 125 BMF projects of size of 200 animals per BMF project. Further, it was mentioned that total 10 projects of the capacity of 50 animals are active projects out of 121 total active projects. Thus total space of 11.5 projects of 200 animals per BMF will be available for further sanctioning.

2.4 Waitlisted projects at S. No. 1, 3, and 7 are of a capacity of 50 animals. After discussion, it was decided to approve 13 projects at S. No. 1 to 13 under the component of establishment of BMF, as per the details provided at **Annexure-III**, subject to the condition that the revalidation of the bank loan shall be provided within 15 days of the date of sanction. If revalidation of bank loan letter is not received within 15 days then next wait listed project will be considered.

Agenda 3: Strengthening of semen station - Bassi, Jaipur

3.1 RCDF has submitted a proposal for Strengthening of Semen Station Bassi, Rajasthan with the total cost of Rs. 7728.29 lakh. The project was appraised in the Division as per norms of the scheme.

3.2 After detailed discussion project was approved with an allocation of Rs. 6415.50 lakh as per the details at **Annexure-IV**.

Agenda 4: Strengthening of semen station – Jodhpur, Rajasthan

4.1 RCDF has submitted a proposal for Strengthening of Semen Station Jodhpur, Rajasthan with the total cost of Rs. 4060.75 lakh. It was mentioned that project was appraised by NDDDB as per guidelines of the scheme.

4.2 After detailed discussion project was approved with an allocation of Rs. 3656.10 lakh as per the details at **Annexure-V**.

Agenda 5: National Digital Livestock Mission

5.1 It was mentioned that National Digital Livestock Mission is approved activity of Rashtriya Gokul Mission (CCEA MoM dated 19.07.2021). The NDLM project was approved by Project Sanctioning Committee during its meeting held on 05.03.2021 and 03.06.2021 with stipulation that funding for the project shall be shared in 50:50 ratio by DAHD and NDDDB and release of an amount of Rs 51 crore as Gol share. NDDDB has contributed Rs 51 crore as their matching share for development and maintenance of the software. Under revised RGM approved by the Cabinet during its meeting held on 19.03.2025 an amount of Rs 25 cr has been allocated for management of NDLM. Further it was mentioned that as directed by Hon'ble MoS the work of Livestock Census in the country was

included under NDLM and the Department has also directed to undertake new requirements of flock management, Registration of stray animals, development of Dairy Vikas Portal, Analytic MIS Portal etc. These additional works are DAHD requirements hence contribution of NDDDB is not required in the present case.

5.2 After detailed discussion the project was approved with an amount of Rs 49.74 cr (Rs 24.74 cr for extended scope of work and Rs 25 Cr as cloud cost).

The Meeting ended with a vote of thanks to the Chair.
