First Schedule to e-Tender enquiry

Tender Enquiry No. AE-15011/44/2025-Store-S (E. No.37577) for outsourcing the job of unloading, weighing and stacking and counting of Packed Ghee Carton of 12 ltrs each from vehicle to DMS Godawn.

1. Description of Job : Outsourcing the job of unloading, weighing and stacking and counting of Packed Ghee Carton of 12 ltrs each from vehicle to DMS Godawn.
2. Rates : Rates may be offered in financial bid in (.xls) and price breakup in (.pdf)
3. EMD to be deposited : Rs. 5,000/-

Scope of Work:- Job of unloading, weighing, stacking and counting of Packed Ghee Carton of 12 ltrs. each from vehicle to DMS Godawn as when require basis.

Terms & Conditions:-

1. **Period of Contract:-** The above job shall be awarded initially for the period of two years which can be extended for further period of six months depending upon the satisfactory performance and at the sole discretion of General Manager.
2. **Rate:-** The bidder are requested to provide rates/offer for unloading, weighing, stacking and counting of Packed Ghee Carton of 12 ltrs. each from vehicle to DMS Godawn on per liters (inclusive of all charges +taxes etc.) basis.
3. **Documents to be submitted for eligibility criteria:-**
 - (i) The firm is required to submit Aadhar and Pan Card along with his rate offer.
 - (ii) The firm is also required to submit GST certificate along with his rate offer.
4. **EMD Deposit:-** MSE and Startup Enterprises are exempted from depositing EMD, relevant certificate for exemption is to be submitted. Under MSE category, only manufacturers for Goods and Service Providers for Services are exemption from EMD. Other firms have to deposit EMD of Rs.5,000/- in form of FDR, Demand Draft/Pay Order along with tender in favour of General Manager, Delhi Milk Scheme
5. **Security Deposit:** You are required to deposit 5% security amount of the total value of the contract in the shape of Demand Draft/Pay order/FDR in favour of General Manager, Delhi Milk Scheme within 10 days from the issue of the job order failing which contract may be cancelled. The security amount shall be refunded after completion of job.
6. **Payment: Payment terms:** The payment shall be made on monthly basis on actual quantity of ghee unloaded as per scope of work. The contractor is required submit the bills after completing three months period and duly Certified by ASO (R&G) to AO (I) Store Payment Section for arranging payment.
7. **Site Visit:** Before quoting the rates, the contractor may visit Delhi Milk Scheme to access quantum of work and the requirement of items for carrying out the job in time. Any clarification required may be got from ASO (R&G) of DMS on any working days between 10 am to 4 pm. No request will be considered after opening of e-Tender.
8. **Statutory and Mandatory Provision :** The contractor shall abide by all the statutory and mandatory provisions of labour/Industrial laws in force from time to time. In case any challan/ fine is levied under Statutory Act, DMS will not be responsible for any violation of law by Party and the contractor will be fully responsible for its settlement and of any statutory and the mandatory requirements such as Medical, Insurance etc.
9. **Compensation:** In the event of an accident or mishap resulting in any disability, injury or death of employee engaged by party during the period of the contract the compensation,

damage etc. are to be paid by contractor. DMS shall not be liable in any manner either monetarily or otherwise.

10. **Safety Guidelines :** Tenderer should ensure that the staff deployed by him follow all statutory and safety guidelines while working. In this connection DMS in no way will be responsible for any untoward happenings during the contract period.
11. **Statutory Requirement :** The contractor is required to abide by all statutory requirements as per Law applicable during the contract period.
12. **Modification:** In case of any hardship/operational problems faced by either party (i.e. contractor or DMS). General Manager, DMS have the right to add/modify any conditions in the public interest by recording reasons to this effect.
13. **Short Close of Contract:**(i) On breach of any terms and conditions, the said contract can be short closed/cancelled at any time without assigning any reason at the sole discretion of General Manager, Delhi Milk Scheme. (ii) The contract can be short closed at any time if O & M of DMS is given to external agency or DMS activity is closed due to any reasons, whichever is earliest. (iii) In case of closure of DMS activities, contract may be short closed without any notice. (iv) In case of shifting of entire DMS operation to any other Milk Union/Dairy Federation etc and/or short closing/termination MoU between DMS and Haryana Dairy Federation, the above contract can be short closed. (v) The contract can also be short closed under any unforeseen circumstances beyond the control of DMS.
14. **Manual Tender:** Manual tender shall not be accepted .
15. **Validity of Tender:** Your Tender offer should be valid for a period of 180 days from the closing date of tender.
16. **Jurisdiction:** All dispute arising out of or touching on the contract shall be subjected to the jurisdiction of the court of Union Territory of Delhi only.
17. **Instruction for bidders for filling/bidding E-Tender.**

- a. As this is e-tender enquiry, all bidders are requested to obtain Digital Signature Certificate (DSC) for bidding the above tender.
- b. E-Tender Enquiry & tender acceptance letter duly signed by bidder and related documents may be uploaded in (.pdf) file. If above tender enquiry document are not signed by bidder the same shall be summarily rejected.
