**Sub: Revised threshold values for submission of Quarterly Progress Report – QPR.**

In supersession of the Commission's earlier OMs on the subject, the threshold limits for reporting of procurement contracts in the QPR to the Commission, are revised as under:

S. No.	Nature of Procurement	Revised Value
1	<b>Works</b>	
(a)	Civil Works	Rs. 15 Crore & above
(b)	Electrical / Mechanical / Electronics / Instrumentation / Telecommunication Works, etc.	Rs. 5 Crore & above
(c)	Horticulture Works	Rs. 20 Lakh & above
2	<b>Goods</b>	
(a)	All Goods / Stores / Equipments except 2(b), 2(c) & 2(d)	Rs. 10 Crore & above
(b)	Medical Equipment	Rs. 2 Crore & above
(c)	Supply of Medicines, Vaccines, etc.	Rs. 50 Lakh & above
(d)	Sale of Goods / Scrap / Land, etc.	Rs. 5 Crore & above
3	<b>Consultancy Services</b>	Rs. 2 Crore & above
4	<b>Non-Consultancy Services</b>	Rs. 2 Crore & above

2. QPRs may be submitted both in softcopy (in MS excel format) through e-mail at [tegcteocvc@gov.in](mailto:tegcteocvc@gov.in) as well as hardcopy separately for each sub-category mentioned above.


3. While submitting the QPR to the CTEO, CVOs should keep the following points in view:
- (i) The QPRs of different nature of procurement should be submitted on separate sheets of paper.
  - (ii) The "Online Submission" of QPR through CVC Portal is in process. The detailed instructions on this would follow.
  - (iii) The extant manuals (Manual for Procurement of Works, Manual for Procurement of Goods, Manual for Procurement of Consultancy Services and Manual for Procurement of Non-Consultancy Services) published by Department of Expenditure, Ministry of Finance may be referred for clarification, if needed.
  - (iv) In case of composite 'Works' procurements, the larger component may decide the nature of procurement for sub-categorization.
  - (v) The cost of the contract relates to the accepted / tendered / work order value of the contract and not the estimated cost.
  - (vi) If one Ministry / Department / Undertaking / Autonomous Body of the Central Government has entrusted the work to another Ministry / Department / Undertaking / Autonomous Body of the Central Government for execution, the work should be reflected in QPRs of both the Organisations.
  - (vii) The location of the work must be indicated.
  - (viii) Use of abbreviations that are not known ordinarily should be avoided.
  - (ix) Works include contracts in Turnkey / Engineering, Procurement & Construction (EPC) / Public-Private Partnership (PPP) and other form of contracts.
  - (x) Civil Works also include marine, mining, and purchase of "ready built properties".
  - (xi) Electrical / Mechanical works also include air conditioning, firefighting, fire alarm and all other allied works.
  - (xii) The procurement of integrated IT Projects should normally be carried out as procurement of Consultancy Services.
  - (xiii) In case, there are no procurement contracts (including Works, Goods, Consultancy Services, Non-Consultancy Services) awarded more than the threshold value mentioned under each category, two contracts with highest value in each of such category should be reported. In case no contracts are awarded, "Nil" QPR may be sent.
  - (xiv) In case the contracts are placed in foreign currency, the threshold limit would be determined based on conversion of foreign currency with Indian Rupee at the exchange rate defined in the tender documents. However, the currency of payments may also be indicated as per the contract.

- (xv) Contracts awarded on Assignment / Nomination / Single Tender / Original Equipment Manufacturer (OEM) / Original Equipment Supplier (OES) / Proprietary Article Certificate (PAC) basis falling in the above procurement shall also be reported.
- (xvi) For furnishing the QPR related to Sale of Goods / Scrap / Land, etc., the QPR may also indicate the reserve price besides the sale price.
- (xvii) The organisations shall report all types of contracts irrespective of their role as Chief Owner or Engineer-in-Charge of the Contract or Project Management Supervision Consultant.
- (xviii) All procurement contracts (including Works, Goods, Consultancy Services, Non-Consultancy Services) whether in India or outside India in progress, contracts awarded, and the contracts completed during the quarter shall be included in the QPR. In respect of contracts completed during the relevant quarter, the actual date of completion shall be indicated.
- (xix) While submitting the QPR, CVO to certify that all Works / Goods / Consultancy Services / Non-Consultancy Services required to be reported have been included in the QPR.
- (xx) The format for submission of QPR is at **Appendix- I**.

4. The contents of the circular may be brought to the notice of all concerned.
