

It may be noted that Department of Expenditure (DoE) has now revised and released the Manual for Procurement of Works, Second Edition 2025, after issuance in 2019 and updated in 2022. This manual incorporates significant policy changes resulting from stakeholder discussions, FTA dialogues, COVID policy responses, various studies and reports, amendments to General Financial Rules (GFR) 2017, Delegation of Financial Powers Rules (DFPR) 2024, and new legislative developments such as the Mediation Act – as well as evolving practices in the procurement ecosystem.

2. Now, therefore, following updated procurement manuals issued by DoE are available as on date:
- Manual for Procurement of Goods, Second Edition, 2024.
 - Manual for Procurement of Consultancy Services, Second Edition, 2025.
 - Manual for Procurement of Non-Consultancy Services, 2025.
 - Manual for Procurement of Works, Second Edition, 2025.

3. The Commission has desired that all the Chief Vigilance Officers may take note of the above updated procurement manuals of DoE and bring the same to the notice of Chief Executive / Management of their organisations for (i) strict compliance; and (ii) updation / aligning of their own procurement manuals / guidelines in sync with these manuals of DoE.
