*Dear Sir / Madam,*

I would draw your kind attention to my letter dated 28<sup>th</sup> October 2021, vide which I had communicated the allocation of and sanction of funds for Mobile Veterinary Units (MVU) under LH&DC scheme (copy enclosed). In addition to follow-up communication (dated 11/2/2022) enquiring about the method and progress of procurement and fabrication of Mobile Veterinary Units, Video Conferences were held with States/ UTs where various vehicle manufacturers too participated. However, the status of procurement and readiness of these MVUs is yet to be obtained from you.

In this connection, kindly note that we had already shared with you in the Operational Guidelines, the list of equipment and other paraphernalia required to be kept in the MVU. However, to clarify further, DAHD has formulated an advisory for MVUs, identifying a list of specifications for fabricating and customizing the mobile vehicles, in order to standardize the procurement and fabrication process across all states/UTs, while being mindful of the respective geographical specificities and challenges posed by different geographical terrains. A copy thereof is enclosed for adherence.

Further, I would share with you the poster with a logo, which has been designed to be attached on the exterior of the veterinary vehicles. This poster will help livestock farmers/stakeholders to identify the purpose of these MVUs and thereby ensure quicker access to veterinary services widely.

Accordingly, I would request you to use this as a guidance document in completing the procurement and fabrication of MVUs, in your state/UT, at the earliest.
