G.S.R. _____ - In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of Ministry of Agriculture, Department of Animal Husbandry, Dairying and Fisheries, Central Herd Registration Scheme, Stockman (Selection Grade) and Stockman (Junior Grade) Group C post, recruitment rules 2015, in so far as they relate to the post of Stockman (Selection Grade) and Stockman (Junior Grade), except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Stockman (Selection Grade) and Stockman (Junior Grade) in the Ministry of Fisheries, Animal Husbandry and Dairying, Department of Animal Husbandry and Dairying, Central Herd Registration Scheme namely :-

1. Short title and commencement.- (1) These rules may be called Ministry of Fisheries, Animal Husbandry and Dairying, Department of Animal Husbandry and Dairying, Central Herd Registration Scheme, Stockman (Selection Grade) and Stockman (Junior Grade) Group C posts, Recruitment Rules, 2023.

(2) They shall come into force on the date of their publication in the Official Gazette.
2. Application - These rules shall apply to the posts specified in column (1) of the Schedule annexed to these rules.
3. Number of posts, classification and the pay matrix level or pay scale. - The number of the said posts, their classification and the pay matrix level or pay scale attached thereto shall be as specified in columns (2) to (4) of the aforesaid Schedule.
4. Method of recruitment, age-limit and other qualifications etc. – The method of recruitment to the said posts, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedule.
5. Disqualification. – No person, -
 - (a) who has entered into or contracted a marriage with a person having a spouse living, or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said posts:

Provided that the Central Government, may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. Power to relax. – Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
7. Saving. – Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, the Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
