Madam/Sir,

I am directed to convey the sanction of the President for release of Grants-in-aid amounting to **Rs.77312500/- (Rs.Seven Crores Seventy Three Lakhs Twelve Thousand Five Hundred Only) (25% of total project costs of Rs.309250000/-) to M/s Krishi Vikas Sahakari Samiti Ltd (KVSSL) towards Assistance for Quality Fodder Seeds Production under National Livestock Mission during the F.Y 2022-23**

2. The programme is to be implemented during the F.Y. 2022-23 on the following terms and conditions.

- Central Grant is sanctioned on the condition that this will be utilized for specific purpose and places/projects as per the proposal submitted by Director KVSSL vide letter no.KVSSL/2022-23/GGN/08 dt 20.4.2022 forwarded by Joint Secretary(Seeds) MoA &FW via mail dt May 13,2022.The detail fodder seed production programme/activities to be undertaken will be intimated separately.
- The estimated expenditure is to be treated as maximum and all efforts will be made to effect as much economy as possible without deterioration of the scheme and also that the expenditure incurred within the ceiling approved by the Government of India.
- The **implementing agency** will maintain proper account of expenditure incurred and submit the statement of the audited accounts to the Government of India in due course.
- The account of grant shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC), 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution/Organization is called upon to do so.
- The organization shall submit an audited certificate of actually utilized grants in-aid sanctioned in prescribed Performa as per GFR, 2017 specifying report on targets and achievements cum performance report to the sanctioning Authority.
- The proposal will be implemented by the Implementing agency strictly as per the guidelines contained in the Scheme; conditions laid down in administrative approval issued by this

department's letter vide No. R-99014/6/2022-FF [E21757] dated 8th April 2022 and as per the proposal approved by this Department.

3. The expenditure of **Rs.77312500/-**(Rs.Seven Crores Seventy Three Lakhs Twelve Thousand Five Hundred Only) shown in para 1 above, may be debited to the following head of account:

The further use of Grants in Aid being released by this sanction order is to be done through Expenditure and Advance Transfer (EAT) module of (PFMS).The Utilization Certificate not supported by the EAT module data is likely to be rejected and expenditure is not to be treated as regular.The Agency would be forced to refund the amount received as the expenditure not appearing in EAT module data is not to be taken as expenditure incurred in accordance with the terms and conditions of this sanction order.The grantee institution/implementing agency shall also submit UCs on PFMS.
