Madam/Sir,

I am directed to convey the sanction of the President for release of Grants-in-aid amounting to **Rs. 17,73,15,000/- (Rs.2nd installment of Rs.7,73,12,500/- (25 % of total project cost of Rs. 30,92,50,000/- approved for kharif 2022-23 which is under implementation and Ist installment of Rs. 10,00,02500/- (25 % of total project cost of Rs.40,00,10,000 for implementation of programme for Rabi 2022-23 to M/s Krishi Vikas Sahakari Samiti Ltd (KVSSL) towards Assistance for Quality Fodder Seeds Production under National Livestock Mission during the F.Y 2022-23.**

2. The programme is to be implemented during the F.Y. 2022-23 on the following terms and conditions.

- Central Grant is sanctioned on the condition that this will be utilized for specific purpose and places/projects as per the proposal submitted by Director KVSSL vide letter no.KVSSL/2022-23/GGN/08 dt 20.4.2022. and N.KVSSL/2022-23/GGN/109 dt 15.9.22.The detail fodder seed production programme/activities for Kharif 2022 has already communicated and for programme/activities to be undertaken for Rabi 2022-23 will be communicated separately.
- The estimated expenditure is to be treated as maximum and all efforts will be made to effect as much economy as possible without deterioration of the scheme and also that the expenditure incurred within the ceiling approved by the Government of India.
- The **implementing agency** will maintain proper account of expenditure incurred and submit the statement of the audited accounts to the Government of India in due course.
- The account of grant shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC), 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution/Organization is called upon to do so.
- The organization shall submit an audited certificate of actually utilized grants in-aid sanctioned in prescribed Performa as per GFR, 2017 specifying report on targets and achievements cum performance report to the sanctioning Authority.
