Sir,

This is in reference to the proposal received from Commissioner and Secretary, Animal Husbandry and Dairying Department, Government of Haryana vide letter dated 18(CFMS)-AH-4-2022/2855 dated 25.05.2022, I am directed to convey the Administrative approval of Rs.40,80,00,000.00 (Rupees Forty crore eighty lakh only) and expenditure sanction of the President of India for the payment of Grants-in-Aid amounting to Rs.10,20,00,000/- (Rupees Ten crore twenty lakh only) as 100% Central Grants to the State Implementing Agencies/Livestock Development Board of the Department of Animal Husbandry & Veterinary Services of Government of Haryana, during FY 2022-23 under National Animal Disease Control Programme for Foot and Mouth Disease and Brucellosis (NADCP) a component of Livestock Health and Disease Control Programme a Centrally Sector scheme during 2022-23 for procurement of Cold Chain equipment for procurement of Cold Chain equipment as mentioned in the proposal to accommodate the vaccine doses required to carry out vaccination under LHDCP effectively, the detail of which is as under:

2. Further, I am directed to convey that AHD, Haryana is allowed to procure Vertical ILRs with WHO PQS performance certification as mentioned in the proposal.

3. The Grants-in-Aid of Rs.10,20,00,000/- (Rupees Ten crore twenty lakh only) as Central Grants is being released in accordance with the approved pattern of financial assistance under the Scheme.



6. The central funds may be utilized strictly as per approved activities & Budget for the year. If any inter component re-appropriation becomes necessary, prior approval of the Govt. of India should be obtained.
7. This Sanction is issued in exercise of delegated powers and with the concurrence of Finance Division of Ministry of Fisheries, Animal Husbandry and Dairying, Department of Animal Husbandry and Dairying vide their **Diary No.14224/AS&FA dated 26.07.2022.**
8. As per Rule, 149, GFR,2017 all the procurement should be done mandatorily through GeM.
9. It is certified that the expenditure of Rs.10,20,00,000/- (Rupees Ten crore twenty lakh only) has been duly noted in the Expenditure control register at Serial No. 02 on Page No.102 as stipulated in GFR rule 212(4)(b).
10. The Accounts regarding release of funds and their utilization shall be open to inspection by the sanctioning authority and audit, both the Comptroller and Auditor General of India and Internal Audit of the Principal Accounts Officer of this Ministry.
11. **The further use of Grants in Aid being released by this sanction order, is to be done through (PFMS). The Utilisation Certificate not supported by EAT module data is likely to be rejected and expenditure is not to be treated as regular. The State/Agency would be forced to refund the amount received as the expenditure not appearing in EAT module data is not to be taken as expenditure incurred in accordance with the terms and conditions of this sanction order.**
12. The State Governments is also requested to ensure registration of all the implementing agencies till last levels and use of Expenditure, Advance and Transfer (EAT) module of Public Financial management System (PFMS) for flow of funds so that effective monitoring of funds utilization can be done as per Rule 232 (v) of GFR 2017.
