S.O. 2825(E).—In exercise of the powers conferred by section 3 of the Live-stock Importation Act, 1898 (9 of 1898), the Central Government hereby makes the following further amendment in the notification of the Government of India, in the Ministry of Agriculture, Department of Animal Husbandry, Dairying and Fisheries, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii), *vide* number S.O. 1495 (E), dated the 11th June, 2014, namely:-

In the Schedule to the said notification, in paragraph 1, for the proviso, the following proviso shall be substituted, namely:-

“Provided that a pet dog or pet cat as permitted under the applicable baggage rules shall be allowed to be imported through Cochin International Airport, Cochin till 30th September, 2021.”
