**Subject:- Release of Central Assistance of Rs.6220600/-during 2019-20 under National Livestock Mission for the State of Uttar Pradesh.**

Sir,


I am directed to convey the sanction of the President of India for the payment of Grants-in-aid amounting to **Rs.6220600/-** (Sixty Two Lakhs Twenty Thousand Six Hundred Only) to Government of Uttar Pradesh, Department of Animal Husbandry under MH-3601 (TSP) of National Livestock Mission Scheme for implementation of various components as detailed in **Annexure** during 2019-20 in the State.

2. The programme is to be implemented during 2019-20 on the following terms and conditions.
  - (a) Central Grant is sanctioned on the condition that this will be utilized for specific purpose and places / projects as per the proposal submitted by the State Government vide their letter No.4036/Thirty seven-2-2018-30(83)/14 dated 3<sup>rd</sup> December 2019 from Principal Secretary, Uttar Pradesh, Administration.
  - (b) The Government of Uttar Pradesh would arrange matching share for each component as mentioned (as per the guidelines of the scheme) during 2019-20.
  - (c) The estimated expenditure is to be treated as maximum and all efforts will be made to effect as much economy as possible without deterioration of the scheme and also that the expenditure incurred within the ceiling approved by the Government of India.
  - (d) The State Government of Uttar Pradesh will maintain proper account of expenditure incurred and submit the statement of the audited accounts to the Government of India in due course.
  - (e) In terms of relevant rule of General Financial Rules, 2017 the account of Grantee institutions or organization shall be open to inspections by the sanctioning authority and audit both by the Controller and Auditor General of India and under the provision of CAG (DPC), 1971 and under audit by the Principal Account Officer of the Department, whenever the Institution/Organization call to do so.
  - (f) The State Government/Grantee organization shall submit an audited certificate of actually utilization grants in-aid sanctioned in prescribed Performa as per GFR, 2017 specifying report on targets and achievements cum performance report to the sanctioning Authority.
  - (g) The account of grant shall be opened to check test by the Comptroller and Auditor General of India at his discretion.
  - (h) The proposal will be implemented by the State Government strictly as per the guidelines contained in the scheme; conditions laid down in administrative approval issued by this department's letter vide No. 99-6/2018/NLM/Admn. Approval dated 26.04.2019 such as women beneficiaries, etc. and as per the proposal approved by this Department.
