**Subject: - Release of Central Assistance of Rs.26, 55,000/- during 2020-21 under National Livestock Mission to the State of Himachal Pradesh.**

Sir,

I am directed to convey the sanction of the President of India for the payment of Grants-in-aid amounting to **Rs.26,55,000** (Rupees Twenty Six Lakh Fifty Five Thousand Only) to Government of Himachal Pradesh, Department of Animal Husbandry under MH-3601 (TSP) under National Livestock Mission Scheme for implementation of various components as detailed in **Annexure** during 2020-21 in the State.

2. The programme is to be implemented during 2020-21 on the following terms and conditions.
- Central Grant is sanctioned on the condition that this will be utilized for specific purpose and places / projects as per the proposal submitted by the State Government vide their letter AHY-H (II)-F-7-27/76-VII dated 22.05.2020 from Director, Animal Husbandry, Himachal Pradesh, Shimla-5.
  - The Government of Himachal Pradesh would arrange matching share for each component as mentioned (as per the guidelines of the scheme) during 2020-21.
  - The estimated expenditure is to be treated as maximum and all efforts will be made to effect as much economy as possible without deterioration of the scheme and also that the expenditure incurred within the ceiling approved by the Government of India.
  - The State Government of Himachal Pradesh will maintain proper account of expenditure incurred and submit the statement of the audited accounts to the Government of India in due course.
  - In terms of relevant rule of General Financial Rules, 2017 the account of Grantee institutions or organization shall be open to inspections by the sanctioning authority and audit both by the Controller and Auditor General of India and under the provision of CAG (DPC), 1971 and under audit by the Principal Account Officer of the Department, whenever the Institution/Organization call to do so.
  - The State Government/Grantee organization shall submit an audited certificate of actually utilization grants in-aid sanctioned in prescribed Performa as per GFR, 2017 specifying report on targets and achievements cum performance report to the sanctioning Authority.
  - The account of grant shall be opened to check test by the Comptroller and Auditor General of India at his discretion.
  - The proposal will be implemented by the State Government strictly as per the guidelines contained in the scheme; conditions laid down in administrative approval issued by this

department's letter vide No. 99-6/2018/NLM/Admn. Approval dated 10.04.2020 such as women beneficiaries, etc. and as per the proposal approved by this Department.

- (i) The purchase of items may be done following General Financial Rules 2017 (GFR)/Store purchase rules.
- (j) No double benefit be provided to a farmer under the components.

3. **Rs.26,55,000 (Rupees Twenty Six Lakh Fifty Five Thousand Only)** shown in para 1 above, may be debited to the following head of account:

4. The State Government will utilize the fund for the scheme for which this amount is released and submit the utilization certificate, statement of expenditure and physical progress in stipulated format through Administrative Head to this Ministry in due course as per guidelines for release of balance funds.

5. There is an unspent balance of Rs.752.57 Lakhs for the funds released during 2018-19 with the State Government of Himachal Pradesh

6. The State & UTs will mandatorily source germplasm/Animals/Day old chicks/ Hatching eggs etc from Government organizations including ICAR and Universities as mentioned in the NLM guidelines. If the Government organizations including ICAR and Universities are unable to supply then only it should be sourced from private organizations strictly following the GFRs.

7. The further use of Grants in Aid being released by this sanction order, is to be done through EAT module of (PFMS). The Utilization Certificate not supported by the EAT module data is likely to be rejected and expenditure is not to be treated as regular. The State/Agency would be forced to refund the amount received as the expenditure not appearing in EAT module data is not to be taken as expenditure incurred in accordance with the terms and conditions of this sanction order.


8. The State Government is also requested to ensure registration of all the implementing agencies till last levels and use of Expenditure, Advance and Transfer (EAT) module of Public Financial Management System (PFMS) for flow of funds so that effective monitoring of funds utilization can be done as per Rule 232 (v) of GFR 2017.

9. This issues under the delegated powers and with the concurrence of Integrated Finance Division of this Ministry vide their **Dy. No.7931 /AS&FA dated 24 .06.2020.**

10. This has been noted as per GFR Rule 212 (4) (b) at **S. No. 06 of Pg. No.13** of the Register of Grants under National Livestock Mission for 2020-21.
